#### 3. Mandate

The Centre for Refugee Studies is an interdisciplinary community of researchers dedicated to advancing the well-being of refugees and others displaced by violence, persecution, human rights abuses, and environmental degradation through innovative research, education and policy engagement. Since its inception in 1988, CRS has been recognized as an international leader in the creation, mobilization and dissemination of new knowledge that addresses forced migration issues in local, national and global contexts.

The CRS vision for 2020 - 2026 is to be a world-leading interdisciplinary research centre that enhances the rights and well-being of refugees and other displaced people through research, education, and knowledge mobilization. At a time of unprecedented and ever-increasing human displacement and rapid shifts in responses to this displacement, CRS will improve critical understanding of these phenomena and will advance evidence-informed policy and practice in Canada and abroad.

#### 4. 2023-24 Outstanding Centre-specific Accomplishments

2023-24 was a productive year for the Centre for Refugee Studies. Here are some of our key accomplishments:

• Recruited next CRS Director (Yvonne Su)

- Supported over \$3 million in research grant applications by CRS faculty PIs, securing over \$1.75 million in research funding
- Administered 22 active grants, worth a total of over \$9 million in research funding
- Served as the Secretariat for the Canadian Association of Forced Migration & International Association of Forced Migration secretariats, including hosting the CARFMS Annual Conference at York University as part of Congress
- Hosted Refuge, the leading Canadian interdisciplinary academic journal on forced migration issues
- Held over 15 research events, including our week-long Summer Course, our Seminar Series, and several research dissemination/mobilization events run by our affiliates
- Received 27 affiliation requests and 13 requests for formal visits by forced migration scholars from around the world
- Supported the continued expansion of the CRS co-hosted Refugee Law Laboratory, resulting in new publications, datasets, code repositories, and media reports/quotes
- Produced an extensively researched report on opportunities for interventions to increase research at the intersections of racism and forced migration by the CRS Executive Racism(s) and Refuge Subcommittee of the CRS Executive produced an extensively researched report on opportunities for interventions to increase research at the intersections of racism and forced migration

#### 5. Challenges and Areas for Improvement

While we are proud of what we have achieved at CRS in 2023-24, we face several ongoing challenges:

- Conflicts around the world in 2023-24, including the devastating ongoing violence in Israel/Palestine, have had challenging impacts on forced migration research communities. Labour disruptions at York University this year have also been difficult to manage.
- Dut to frequent, unpredictable, and often unannounced soft (card access only) and hard (no entry/exit) lockdowns of Kaneff Tower, we are no longer able to effectively use our space on campus. We cannot plan events – or even hold office hours to meet with students and community members – with any confidence that people will be able to enter the building. The public cannot reliably access our Resource Centre, including the archives we maintain. Beyond the question of access is also what it means for vulnerable members of our community when our spaces are actively policed by York Security staff, including community members who are racialized, who have precarious immigration status, or who have had prior traumatic experiences with security officials.
- While our closed office workspaces are in high demand, we have not yet returned to pre-Covid levels of in-person engagement at CRS. This is partly attributable to building lockdowns, but it is also a broader problem across campus as we all adjust to increased opportunities for remote work. These opportunities have created welcome occasions for remote engagement with members of our community who are not able to be with us in person, including people facing displacement. However, some thought is needed in terms of how we use our physical spaces on campus and whether they are properly configured.

- Workload sustainability remains a challenge. ORUs lack the institutional powers given to faculties and departments to allocate teaching and administrative assignments. It is difficult for our faculty affiliates to take on responsibilities connected with CRS – such as administering and revising our Graduate Diploma program, running our journal (Refuge), overseeing our Summer Course, taking on an Associate Director role, leading committees, etc – when these roles are not formally considered in assigning faculty teaching and administrative workloads in faculties/departments. This leads the CRS Director to take on many tasks that would ideally be spread across our community. Meanwhile, the CRS Director may not receive sufficient teaching or administrative credit to reflect the workload of running a large ORU with many legacy programs (e.g. at Osgoode Hall Law School: 33% teaching release and no release from any administrative responsibilities).
- Financial sustainability over the long term is also a challenge. In the short and medium terms, we are in excellent financial shape, largely due to VPRI taking on the expense previously borne by CRS for staffing the 6<sup>th</sup> floor Resource Centre (though we are maintaining significant carry forwards in case that changes). In the long term, however, arrangements are needed to allocate a fixed percentage of the equivalent of "overhead" from Tri-Council grants (i.e. RSF) to ORUs that administer grants. If CRS were allocated more of those resources, we could hire staff who could help us bring in additional resources, who could further amplify our research, and who could spend time pursuing strategic priorities.
- Canadian visa policy seriously hampers our efforts to host researchers from around the world, especially for researchers from the Global South. While the main problem relates to government policy, York University staff responsible for assisting international students and visitors appear overwhelmed, which is having spillover effects on our staff, who are not qualified or authorized to provide this assistance.

#### 6. Charter Goals

**Fostering and Supporting a Community of Researchers on Forced Migration:** We continued to support forced migration scholars and institutions, including through the journal (Refuge) and scholarly associations (IASFM, CARFMS) hosted at CRS. We assisted our affiliates in pursuing research funding for interdisciplinary research in this area (over \$3 million in applications, \$1.75 million in secured funding), we created venues for disseminating and amplifying research undertaken by our affiliates (Seminar Series, Summer Course, email lists, social media), and we welcomed visitors on research trips. We placed particular focus on supporting emerging scholars and Global South scholars, including through our support for the Migration + Tech Monitor Fellowship program (https://www.migrationtechmonitor.com).

**Education, Refugees & Others with Precarious Status:** We collaborated with the Sanctuary Scholars program and with World University Services Canada to facilitate access to York University for students with refugee backgrounds or with precarious status, and we explored opportunities to assist researchers based in other institutions in creating additional pathways for post-secondary education for refugee students and other students with precarious status. We also administered bursaries and scholarships for displaced students and for students studying displacement. We supported a large SSHRC Partnership Grant in the area ("Equitable opportunities for research and tertiary education for people with lived experience of displacement", C. Clark-Kazak, University of Ottawa, PI).

**Refugee Law Laboratory:** We continued to build the Refugee Law Laboratory, including our refugee data visualization portal (<u>https://rllp.ca</u>), our annual release of statistics on Canadian

refugee adjudication (<u>https://refugeelab.ca/projects/refugee-law-data</u>), our Refugee Law Lab Reporter (<u>https://refugeelab.ca/rllr</u>), and our most recent bulk legal datasets project, which is the largest bulk open-access dataset of Canadian case law available for researchers looking to work programmatically with legal texts as data (<u>https://refugeelab.ca/bulk-data</u>). We published several outputs, including the latest book by RLL Associate Director, Petra Molnar, *The Walls Have Eyes: Surviving Migration in the Age of Artificial Intelligence*. Our Lab also featured prominently in the media.

**Environmental / Disaster Induced Displacement**: We awarded the 2023 Anthony Richmond Scholarship for graduate research at the intersections of migration and environmental change to Dheman Abdi, a Political Science MA student (and a first generation Somali Canadian) studying the politics of migration and anthropogenic climate change. We are also excited by successful grant applications that we supported in the area, including a large NFRF grant ("Climate Change Adaptation, Dispossession and Displacement: Co-constructing Solutions with Coastal Vulnerable Groups in Africa and Asia", M. Hynie PI) as well as a smaller SSHRC Connection grant ("Stories of Change: Listening to Global South Perspectives on Climate-Induced Migration", Y. Su PI).

**Health, Refugees & Covid-19:** Many of our affiliates continued to work on the intersections of health and forced migration, including M. Hynie, R. Haghiri-Vijeh and F. Ahmad. We also supported an ongoing CIHR-funded project specifically about Covid-19 and refugees ("Refugee integration and long-term health outcomes in Canada: COVID-19 and Newcomers", M. Hynie PI).

**Student Programs:** We continued to deliver the CRS Graduate Diploma in Refugee and Migration Studies, although that program would benefit from revisions and renewal. We also continued to welcome to our Seminar Series students involved in the Undergraduate Certificate in Refugee and Migration Studies housed in LA&PS. Our 2023 CRS Summer Course was successful and attracted participants from around the world. The CRS Student Caucus continued to work on regaining the momentum lost during the disruptions caused by Covid-19 and the more recent strike.

**Post-Covid Priority Setting:** CRS identified undertaking work on race, forced migration and racialized refuge as a key priority during the current Charter. The CRS Executive Subcommittee on Racism(s) and Refuge prepared an extensive report on the subject – portions of which we hope to publish to share with the broader community. The Executive accepted several recommendations set out in the Report, including funding the Subcommittee for an additional year to undertake further work in the area.

Graduate Diploma

In 2023-24, the CRS Director liaised with LA&PS Associate Dean Research & Graduate Studies regarding our Graduate Diploma program. Specifically, we had initially been informed (without notice) that our Graduate Diploma program was going to undergo cyclical review quality assurance. After further discussion, it was agreed that this would occur in 2024-25 instead so that we could plan our work in advance.

#### Undergraduate Certificate

While CRS participates in the Undergraduate Certificate through the CRS Seminar Series and through the CRS Student Caucus, we are not responsible for administration of the program, which occurs via Equity Studies.

#### CRS Summer Course

The CRS Summer Course is a non-credit course that is not housed in a particular faculty or department. Like other non-credit knowledge dissemination / knowledge mobilization activities undertaken by ORUs (e.g. conferences, workshops, seminars), it is not subject to oversight via faculties or departments, other than through regular ORU governance processes (i.e. Board, Senate).

- Continuing to build the CRS co-hosted Refugee Law Lab, including supporting research and infrastructure grant applications
- Exploring additional research partnerships, with a focus on scholars and institutions from the Global South
- Enhancing opportunities and pathways for students and scholars with forced migration backgrounds, including through strengthening collaborations on campus and externally
- Developing strategies for re-engaging students and faculty in person, including considering ways to revitalize and re-arrange the physical space at CRS
- Overseeing the Graduate Diploma in Refugee and Migration Studies, and providing access to our Seminar Series to students in the Undergraduate Certificate in Refugee and Migration Studies program

- Administering the 6<sup>th</sup> Floor Resource Centre, supporting efforts to digitize our archives, and participating in ongoing discussions about the future of the Resource Centre
- Maintaining the CRS Executive Racism(s) and Refuge Sub-Committee, and considering recommendations and possible implementation arising from it
- Continuing to serve as the secretariat for the International Association for the Study of Forced Migration (IASFM) and the Canadian Association for Refugee and Forced Migration Studies (CARFMS), and hosting the interdisciplinary journal, Refuge
- Updating the visual presence of CRS (both in person and virtual)
- Exploring fundraising and philanthropic opportunities to pursue CRS strategic priorities

- Refuge editorial team members hosted a (recorded) "meet the editors" webinar (in English and in French, March 11)
