# **Expanded Course Description**

**Lecture**: The lecture will focus on the anatomy and physiology of the central and peripheral autonomic nervous system, and on the methodologies used to measure autonomic function in research and clinical settings. Students will learn about autonomic reflexes that are active during exercise such as the chemoreflexes, metaboreflex, mechanoreflex and baroreflex. Further, they will learn how each of these reflexes can influence the cardiovascular system at rest and during exercise.

Online lectures will be made available for students to watch prior to the corresponding review class the following Monday. Each Monday, students will review the online lecture prior to participating in group discussions of 2 research articles each week. Research articles need to be read before Monday's class. Refer to the posted lecture schedule for specific dates of lectures/assignments/exams.

Lab: Labs will consist of learning the techniques necessary to collect and analyse autonomic function data consisting of a standard clinical autonomic assessment. This will include resting heart rate variability, respiratory sinus arrhythmia, and the blood pressure and heart rate responses to Valsalva and 10 minutes of head up tilt or stand. Students will also be given pre-recorded Muscle Sympathetic Nerve Activity (MSNA) data at rest and during handgrip exercise. Graduate students will attend an in-person lab and complete an assignment, undergraduate students have the option to attend an in-person lab (optional) and will have access to online videos of the data collection. The lab collections and analysis will be examined on the final exam.

**Presentation**: Students will choose a clinical condition which experiences autonomic dysfunction (e.g. Diabetes, Postural Orthostatic Tachycardia Syndrome, Heart Failure, Chronic Obstructive Pulmonary Disease, Concussion, Sleep apnea). Students will provide the class a key points summary prior to their presentation on the topic. These presentations and subsequent discussion will be examined upon for the Final Exam. Graduate students will present alone, undergraduate students will present in groups of up to 4 people. The presentation is worth 15% and the key points summary document is worth 5% of their final grade.

### **Course Objectives**

This course describes the autonomic nervous system including central and peripheral aspects i.e. brain regions, parasympathetic system, and sympathetic system. Students learn methodologies for measuring

parasympathetic and sympathetic activity in both experimental and clinical settings. Lastly, students discuss the role of the autonomic nervous system in various clinical conditions including postural orthostatic tachycardia syndrome (POTS), heart failure, and diabetes.

# **Course Text / Readings**

Readings will consist of research articles that will be provided via email, PubMed database, or the Library. Additional readings may be assigned or recommended during the course.

Attendance and participation in polls will require a mobile device (smart phone, tablet, laptop) with the iClicker Reef app or iClicker technology. If this is unavailable to you, please let the instructor know so that alternate arrangements can be made.

# Grading:

#### Senate Policy on Grading Scheme and Feedback

The following two statements were approved by the Senate to include in the course outline: "that, under normal circumstances, graded feedback worth at least 15% of the final grade for Fall, Winter or

Summer Term... be received by students in all courses prior to the final withdrawal date from a course without receiving a grade, with the following exceptions

- graduate or upper level undergraduate courses where course work typically, or at the instructor's discretion, consists of a single piece of work and/or is based predominantly (or solely) on student presentations (e.g. honours theses or graduate research papers not due by the drop date, etc.);
- practicum courses;
- ungraded courses;
- courses in Faculties where the drop date occurs within the first 3 weeks of classes;
- courses which run on a compressed schedule (a course which accomplishes its academic credits of work at a rate of more than one credit hour per two calendar weeks).

Note: Under unusual and/or unforeseeable circumstances which disrupt the academic norm, instructors are expected to provide grading schemes and academic feedback in the spirit of these regulations, as soon as

## **Missed Assessments:**

Students with a documented reason for missing a course test, such as illness, compassionate grounds, etc., which is confirmed by supporting documentation (e.g. doctor's letter) may request accommodation from the Course Instructor. Further extensions or accommodation will require students to submit a formal petition to the Faculty. Assignments or papers must be submitted by 5pm on the due date. Late assignments or papers will experience a grade loss of 25% per day.
