Zoom sessions will be recorded and posted later in the day. Tests will run on Tuesday mornings apart from the last test which runs on Thursday April 7.

Students will be assigned to a specific Teaching Assistant alphabetically by the student's last name (see above table). # **Course Description**

# Technical requirements for taking the course:

Several platforms will be used in this course (e.g., eClass, LaunchPad, Zoom, etc.) through which students will interact with the course materials, the course director / TA, as well as with one another. Students shall note the following:

- Zoom is hosted on servers in the U.S. This includes recordings done through Zoom.

Organization of the course: This online course will be taught remotely in both a synchronous and asynchronous manner. The class time is scheduled on Tuesdays and Thursdays between 8:30 and 11:30 (Toronto time: Eastern Time Zone). Zoom sessions, Tests and Office hours will take place during these times as scheduled. Make sure to reserve this time for course activities. Term tests will run primarily on Tuesdays. On Thursdays at 8:30 we will open a zoom meeting and run mini lectures/discussions/workshops and/or Q&A sessions with myself and/or the Teaching Assistants. The length of these zoom interactions is still to be determined but probably not more than 45 minutes – or 1 hour with breaks. Office hours with myself and the Teaching Assistants outside of the Thursday Zoom Session must be arranged by email. Such additional Office hours can be arranged on Tuesdays in class time. If any further time needs to be arranged, please request by email, and give 3 day/time slots when you are available to meet on Zoom.

Each week there will be course lecture material pre-recorded and uploaded to eClass (see Course Schedule on last page of this syllabus). Important: Not all of the information presented in your textbook text will be covered in the recorded lectures. You are responsible for reading the text (apart from those omissions indicated in the Course Schedule). Lectures are designed to highlight some aspects of the weekly topic and to motivate you to learn. Moreover, some of the lectures will contain information that is not in the textbook and questions pertaining to such information may appear on tests. Any video or other material linked in the course slides or on eClass is also subject to examination on the tests.

# **Class Format and Attendance Policy**

When we have scheduled Zoom sessions, I expect attendance. These will be scheduled in class time on Thursdays and will usually be 45 minutes or less. During this time, we will run polling to see where students' knowledge is and respond with further discussion/ examples and activities to support the online lectures. These will be a social and hopefully fun time for us all. We hope to build the sense of community we will be missing due to this remote teaching experience.

There will also be offline opportunities to interact with course content through Launchpad – a software package that is accessed with the textbook (see Required Textbook). This is a double speed course. It feels as though you are taking two courses at once. There is a lot of work, and most will be on a quick turnaround so be aware of due dates. For example, once a Module Quiz opens on Monday at noon it is due the following Friday at noon. There are Learning curves activities due by 12 noon Monday before the associated Term Test on a Tuesday (NB Test 4 is on a Thursday so those associated Learning Curves will be due on the Wednesday before). No late quiz or activity will be accepted as I only count 36 of the possible 51 opportunities.

# **Program Learning Outcomes**

Upon completion of this course, students should be able to:

- 1. Define psychology and explain how it meets the criteria of science.
- 2. Recognize key concepts, methods, theories and assumptions in psychology.
- 3. Describe basic characteristics of the scientific method in psychology.
- 4. Discern differences between personal views and scientific evidence.

# **Specific Learning Objectives**

The purpose of this course is to introduce students to the broad field of psychology. In addition, it is hoped that students will develop appropriate study habits and critical thinking skills. Time management and attention to detail will be important skills to bring to this fast-paced course. Participation in the Undergraduate Research Participant Pool (URPP) will expose students to ongoing psychological studies at York University.

# **Description of Assignments**

# 1. Online Activities:

a) <u>Launchpad Learning Curves</u> – there will be several of these, the first is a demonstration one and not evaluated BUT you must complete it so that you can practice accessing the course information through Launchpad. During the term you will work through the *51 Learning curves*. We expect you to complete at least 36 for full credit, therefore you can miss a few if needs be. These are due in four groups - the day before the associated Term Test at 12 noon.

The 36 Launchpad learning curves are worth a maximum of 3% of your grade. Each is worth 0.0833%

- b) Online Launchpad Module Quizzes - We will count your best 36 Quizzes. Multiple Module Quizzes open at 12 noon on Monday the week when the course content is discussed and close at 12 noon on the Friday of that week.

  NB with Reading Week you get extra time for those Modules, and in the last week you get less time. You have one attempt for each Quiz. There are 20 questions, and you have 15 minutes to complete them. The 36 Module Quizzes are worth a maximum of 7% of your grade. Each is worth 0.1944%
- 2. Practice Test this will give you experience in doing a multiple-choice test through eClass. It is worth 1% of your grade. It will be on January 25, 2022, starting at 8:30 am. There will be 15 questions and you will have 15 minutes to complete it through eClass. Questions will be presented in a sequential format. You must answer the questions in order. You cannot go back and forward between questions. If you do not answer a question, then you cannot go back later to answer. There will be questions based on this syllabus and both the synchronous and asynchronous material associated with January 11, 2022.
- 3. <u>Term Tests</u> four will be held in during our class time on Tuesdays (and the last Thursday), starting at 8:30 am (see course schedule or table of Assessment on the previous page for dates). The 4 tests are worth 80% of your grade. Tests are non-cumulative and have multiple choice questions. Make sure to note the dates and

plan to be able to complete ALL tests at the assigned time. There are **NO MAKEUPS** for missed tests (see what you must do if you miss a Term Test on the next page). If you miss a test, you will score zero for that test. The optional *cumulative* final can be used to replace one such zero score, or your lowest score if you complete all four tests in the term. - 4. <u>Assignment</u> this will be detailed further on eClass. It is worth 5% of your grade. It will be submitted through a Turnitin link and due at 12 noon Monday, March 14, 2022.
- 5. <u>Undergraduate Research Participation Pool</u> Students in this course have an opportunity to earn up to 4% of their final grade by participating in online/lab research as part of the URPP. <u>URPP for the Fall term starts on January 10<sup>th</sup> and ends on April 14<sup>th</sup>, 2022. For information on this, see <a href="http://www.psych.yorku.ca/urpp/">http://www.psych.yorku.ca/urpp/</a>) and check out the link on eClass to the Student Handbook. If you *do not* want to participate in research, you may opt to submit a 3-page paper summarizing a psychology research article that will be assigned to you. This option is referred to as the Paper Stream. Students who wish to choose this option must email the URPP office before February 14th, further instructions will be obtained once the request is submitted. Acceptable papers will earn up to 4% toward their final grade. The Paper Stream deadline is April 8<sup>th</sup>, 2022. Appeals period is April 18<sup>th</sup> April 22<sup>nd</sup>, 2022.</u>

**IMPORTANT** - To continue taking upper year Psychology courses you MUST pass this course with a grade of 60% or better. I only assess 96% of your course grade as 4% comes from URPP. Be aware that if you DO NOT complete URPP and score 60% on ALL other components you will end the course with 57.6%

#### **Grading as per Senate Policy**

The grading scheme for the course conforms to the 9-point grading system used in undergraduate programs at York (e.g., A+=9, A=8, B+=7, C+=5, etc.). Assignments and tests\* will bear either a letter grade designation or a corresponding number grade (e.g. A+=90 to 100, A=80 to 89, B+=75 to 79, etc.)

# Missed Tests/Midterm Exams/Late Assignment

Students who miss a test or final exam **MUST** do the following:

- (1) Contact their **T.A.** by email **within 48 hours** of the original test or exam. If you cannot contact your T.A. during this 48-hour period, subsequent documentation accounting for the delay **must** be provided.
- (2) Complete the following online form **within 48 hours** which will be received and reviewed in the Psychology undergraduate office. At this time, due to COVID-19 an Attending Physician's Statement (APS) is not required, however, a reason for missing an evaluated component in the course must be provided.

HH PSYC: Missed Tests/Exams Form. Failure to complete the form within 48 hours of the original deadline will result in a grade of zero for the missed quiz or late assignment (no such undocumented missed test can be replaced by the optional cumulative final).

In addition, to the online form, a student's documented reason for a missed test must be submitted. Tests/exams missed due to **non-medical circumstances** must be supported by appropriate documentation, i.e., death certificates, obituary notice, automobile accident reports, police reports, airline/bus ticket/receipt for emergency travel (with date of booking on ticket), etc. Airline/train/bus ticket/receipts for emergency travel must indicate destination, departure, and return dates. Having to take a test in another course on the same scheduled day and time is NOT an appropriate reason to miss a test.

**IMPORTANT NOTE:** Only extremely unusual circumstances will warrant a second chance **if you miss two** term tests. It would be in your best interests to drop or withdraw from the course if you have long term health issues. Permission from the **course instructor** is required before any accommodation can be determined and so a Zoom discussion must happen. Further extensions or accommodation will require students to submit a formal petition to the Faculty.
