## **COURSE DESCRIPTION**

This course introduces students to psychology, the scientific study of behaviour and cognition, by examining the basic principles of psychology and their application to everyday experience. The course surveys some core areas of psychology including research methods, biological bases of behaviour, sensation and perception, memory, and cognition. Note: This course is required for all students who intend to pursue additional courses in psychology at the 2000, 3000 and 4000 levels. Students must pass the course in order to pursue further studies in psychology.

## **LEARNING OBJECTIVES**

Upon completion of this course, students should be able to:

- 1. Define psychology and explain how it meets the criteria of science.
- 2. Recognize key concepts, methods, theories and assumptions in psychology.
- 3. Describe basic characteristics of the scientific method in psychology.
- 4. Discern differences between personal views and scientific evidence.

## **SPECIFIC LEARNING OBJECTIVES**

In this course, I hope to provide you an introduction to the exciting field of psychology. More importantly, I hope that you can flexibly and fluently apply the concepts and methods learned in this course to novel scenarios or studies. I hope to provide you with a basis of knowledge that will allow you to seek out and comprehend additional information on your

own. I also hope to provide you information that is timely and current, by using popular media as reference points.

## **Course Requirements and Assessment:**

The lectures will take place in person and will **not** be recorded. This site will be your central access point for course information and materials.

**Turnitin:** To promote academic integrity in this course, you will be required to submit your written work (i.e., mini-assignment, exam answers) through Turnitin (within the course Moodle). Turnitin reviews textual similarity and helps in the detection of possible plagiarism (see below). #### **Course Evaluations:**

In this course, you'll have many chances to earn grades in various ways. Instead of a few big tests, we'll have several smaller assessments. This means that if you don't do well on one assignment, you'll still have plenty of opportunities to improve your grade. Each assessment is worth a relatively small percentage of your overall grade, and tests are not cumulative. I've given you all of the dates, so please make sure to put them in your calendars now with reminders a week or two before, so that you're never feeling surprised by a due date!

**Tests:** Tests will be based on course material associated with the section of the course that is being tested. The test will be lecture-based, meaning that you will **not** be tested on content that appears solely in the textbook (although keep in mind the lectures are strongly based off of the text). **All tests are closed-book and written in-person. You must be present in the classroom for the four term tests. These dates are non-negotiable, and <b>no online options will be provided.** On test days, please bring a pencil and eraser to fill in the scantron. Please do not wear any smart watches on test days. You will also be asked to place your cellphone in your backpack.

**Assignments:** There will be two small assignments in this course. These are both writing assignments that will allow you to apply what you have learned to your everyday life. More information regarding the assignment will be provided later in the term.

**Applied Reflections:** Throughout the semester, I will post discussion forums pertaining to activities we completed in-class. The purpose of these reflections is to give you an opportunity to apply your understanding of core concepts from the course and to assign marks for effort, rather than just correct answers. The TAs will assign marks for responses that show a significant level of effort and thoughtful consideration. You will have 1 week to submit your responses to each forum, but once the next forum opens, you will no longer be able to submit, so put those dates in your calendar early! Each reflection is worth 2%, complete 5 throughout the year to earn a total of 10% toward your grade. There will be more than 5 reflections, meaning that you can choose which 5 to complete and can skip some weeks.

**Research participation:** The final part of your grade in PSYC1010 comes from participating in research studies that are conducted by faculty and students from the psychology department. This is known as the Undergraduate Research Participant Pool (URPP). You must complete a certain number of studies each term in order to receive your full 4% for research participation. If you feel strongly about NOT participating, you will be provided with an alternative written assignment. Please note this is NOT optional. You will receive an email that explains all aspects of the URPP. You can contact URPP at

<u>urpp@yorku.ca</u>. If you have any concerns about the URPP, please email them, not me or the TAs.

**Reviewing Exams and Assignments**: Requests to review exams or assignments should be made within two weeks of the grade posting. Note that grade changes will be made only in exceptional circumstances. After the two-week period, there will be no opportunity for review, or for revisions to grades.

## **Class Format and Attendance Policy**

Students are expected to attend most or all lectures. If you don't attend, you miss out on a lot of what is said, as well as the amazing discussions and fun in-class demonstrations and activities we do. There is a positive correlation between actively participating in the course, asking questions, hearing your classmates' questions and responses, and your overall success in the course.

## **Grading as per Senate Policy**

The grading scheme for the course conforms to the 9-point grading system used in undergraduate programs at York (e.g., A+=9, A=8, B+=7, C+=5, etc.). Assignments and tests will bear either a letter grade designation or a corresponding number grade (e.g. A+=90 to 100, A=80 to 89, B+=75 to 79, etc.)

## Flexible deadlines, late assignments, & missed tests

If you are feeling overwhelmed or double booked, you can use my extension coupons! All students will have three, 24-hour extension coupons that can be used on any assignment in this course (not test), no questions asked, and no documentation required. This means that if an assignment is due Friday at 11:59 pm, using one coupon would mean a new deadline of Saturday at 11:59 pm. You can also use three at one time if you would like. Using three coupons at once would mean a new deadline of Monday at 11:59 pm. To redeem these coupons, email your TA and let them know which assignment you are using a coupon on, and how many coupons you are using. The only rule: these coupons **must** be redeemed before an assignment deadline. After that, the late penalty for an assignment is 10% per day, including weekends. I will accept assignments up to 5 days late. Following that, the assignment will result in a grade of zero.

**Missed Tests:** Students who miss a test due to illness or severe distress must email the instructor and TA within 24 hours and follow the Faculty of Health guidelines for missed tests or examinations. If this missed test is prior to the drop date, regardless of reason, the student has waived the right to have a specific percentage of graded feedback available to them prior to the drop date.

There will be one make-up test session held at the end of the semester. Please note that make-up exams may **not** necessarily be in the same format as the original exam.

For any missed test, students MUST complete the following online form which will be received and reviewed in the Psychology undergraduate office. At this time, due to COVID-19 an Attending Physician's Statement (APS) is not required, however, a reason for missing an evaluated component in the course must be provided.
