Course Description

This is a course in social psychology or the study of how individuals think and feel about, relate to, and influence one another based on the actual, implied, or perceived presence of other individuals. Generally, this course will provide students with a background in social psychology and an opportunity to learn about various theoretical, conceptual, practical, and empirical social psychological issues. I expect that you will work hard, know the course material very well, and be able to integrate the material from different sections. Given that social psychology is related to many aspects of individuals' lives, I think that you will find the study of social psychology engaging and applicable to your life.

Description of Assignments

In-class exams: There will be two 60-item multiple choice in-class mid-term exams in this course. Each exam is worth 30% for a total of 60% of your final grade.

Final exam: There will be one 80-item multiple choice final exam in this course. This exam is worth 40% of your final grade.

Bonus points: two 1% bonus point opportunities (total 2%) will be provided for participating in a social psychological study conducted by an undergraduate honours thesis student, graduate student, or postdoctoral scholar and sanctioned by the instructor. These are extra bonus points and therefore your participation is completely voluntary. This opportunity will be discussed in class.

Grading as per Senate Policy

The grading scheme for the course conforms to the 9-point grading system used in undergraduate programs at York (e.g., A+=9, A=8, B+=7, C+=5, etc.). Assignments and tests* will bear either a letter grade designation or a corresponding number grade (e.g. A+=90 to 100, A=80 to 89, B+=75 to 79, etc.)

Missed Tests/Midterm Exams/Late Assignment:

For any missed tests, midterm exam or late assignments, students **MUST complete** the following online form which will be received and reviewed in the Psychology undergraduate office.

HH PSYC: Missed Tests/Exams Form. Failure to complete the form within 48 hours of the original deadline will result in a grade of zero for the missed midterm exam, final exam, makeup exams, or late assignments.

In addition, to the online form, student's documented reason for a missed tests, midterm exam, final exam, or late assignments such as illness, compassionate grounds, etc., **MUST submit a reason such as an official documentation** (e.g. <u>Attending Physician Statement</u>). The reason for missing an evaluated component in the course **MUST be provided in writing** (Email) to both the instructor and your TA(s) within 48 hours of the missed assignment/exam.

There will be no make-up exams, except under extraordinary circumstances. If you miss one inclass exam, you will receive a grade of zero. If you produce a valid medical document (i.e., an attending physician form), signed by a physician, stating that you were medically unable to take the exam, you will be able to take a makeup exam. A reason for missing an evaluation component in the course must be provided in writing to both the instructor and your TA(s) within 48 hours of the missed exam/assignment. If you miss an exam for non-medical reasons, you still must produce supporting documentation (e.g., death certificate, obituary notice, automobile accident report, airline ticket for emergency travel, etc.). Missing an exam for a vacation, plane tickets, etc., is not an acceptable reason. IT IS IMPORTANT TO NOTE THAT YOU WILL HAVE TO PROVIDE YOUR WRITTEN REASON WITHIN 48 HOURS OF THE MISSED EXAM AND CONTACT THE PSYCHOLOGY DEPARTMENT, INSTRUCTOR, and TA(S) IN ADVANCE OF THE EXAM IF YOU KNOW THAT YOU WILL BE UNABLE TO TAKE THE EXAM. In order to avoid receiving a grade of 0, you must complete Missed Test/Exam Form (see above) and written reason justifying that you were **unable to take the examination** on the scheduled date and time. If this happens to you and you are unable to produce such a document, you should seriously consider dropping this course. If you miss an exam it is your responsibility to contact the TA (the TA is the preferred person) or **course director within 48 hours of the exam.** The nature of the makeup exam will be at the discretion of the instructor. There will be only one makeup exam session for all missed exams for students who qualify for any missed exams. For instance, if you missed 2 regularly scheduled exams, and you qualify for a makeup exam, you would write both missed exams during the makeup exam period. This exam will occur at the beginning of the next semester during the departmental makeup exam period. If you miss the makeup exam for any reason, there will be no other opportunities to earn these grades. It is important that you show up for all exams on time as no late students will be allowed to write the exam following any student's departure from the exam.

Add and Drop Deadline Information
