Minutes of the 126th Meeting of Council May 9th, 2024, 3:00 pm to 5:20 pm | Zoom Meeting Room

1. Call to Order and Approval of the Agenda

The Chair called the meeting to order, noting that an amendment had been made to the Executive Report which is available on the Faculty Council Website, also that the proposals for courses AP/MODR 1730, AP/MODR 1760, and AP/MODR 1770 would be Items for Action, previously part of the Consent Agenda in the CCPS (Committee on Curriculum, Curricular Policy and Standards) report of the Standing Committees to Council. The Chair explained that the Agenda would begin with reports from the Standing Committees of Council, followed by a presentation on the Maclean's University Ranking Survey and concluding with a report from the Dean

Approved with amendments.

2. Chair's Remarks

The Chair thanked staff, Faculty Council, and Executive Committee members their participation and during a difficult year, appealing to members to consider the humanistic tradition and the importance of collegiality.

The Chair reported back on a motion moved by the Department of Humanities at the April 18th meeting of Faculty Council, sharing that after its approval, the motion was forwarded to the Senate for guidance on the application of the motion. The Chair explained that the direction and advice received was that the motion has two elements: an actionable element and a hortative element. The request to postpone

changes to the General Education curriculum and course offerings is considered hortative in nature by the Senate Secretariat. In addition, the Chair noted that the sentiments of Council have been communicated to the Dean's Office, although asking the Dean's Office to postpose its academic programing exercise would appear to fall outside the jurisdiction of Faculty Council's mandate. The Chair added that the decision on academic programing falls within the purview of the Dean's Office as the directive comes from the Board of Governors in response to its fiduciary duties. The Chair addressed the second element of the motion, which requests modes of delivery proposals for general education courses to follow LA&PS's governance structure, which is actionable. According to the Senate policy, if the mode of delivery for a course is not a temporary change, then in consultation with the course director and the department, the course must follow the existing governance pathways for curricular proposals.

4. Business Arising from Minutes

A council member noted that the motion mentioned above was understood to be actionable and sought further comment. A member of the Executive Committee and the Chair explained that although the motion was initially received as a substantive motion, it contains academic issues in addition to fiduciary elements, which are considered hortative in nature. The Dean provided further context, explaining that the Dean's Office must react to Board decisions, which are linked to enrollment trends and budgetary concerns. The Dean added that consultation between units and the Dean's Office including the Associate Dean Programs is continuing, noting that 18 of the 22 units in LA&PS have arrived at an agreement with the Dean's Office. Members requested the Chair report back to with suggestions for next steps regarding the motion.

There was no other business.

5. Reports of the Standing Committees of Council

Executive Committee Report

The Vice-Chair (VC) presented the Executive Committee Report regarding the General Election of the Standing Committees and Senate Representatives of LA&PS. The VC thanked all members of the Faculty, who volunteered for these positions, and welcomed the recently acclaimed members to their respective Standing Committees. He also thanked all members for their contribution to the University at-large.

The VC reported that the current elections period addresses 14 vacancies on Faculty Council Standing Committees and 3 elected-at-large vacancies on Senate, adding that elections were run for the Student Academic Petitions and Appeals Committee, the Committee on Curriculum, Curricular Policy and Standards, the General Education Sub-Committee, the Committee on Teaching, Learning and Student Success (Full-Time faculty), and the Senate Representatives elected at large (Full-Time and Contract Faculty). The VC invited members to view the results of the elections, which were shared in the Executive Report.

Committee on Curriculum, Curricular Policy & Standards

The CCPS Chair provided context for the proposals for changes to existing courses AP/MODR 1730, AP/MODR 1760, and AP/MODR 1770, sharing that the Committee's General Education Curriculum Review Sub-Committee diligently reviews changes to credit weight proposals such as these. A member raised a point of order about the process and speed of the proposals' review and approval. Members also shared concerns about the potential for these proposals to create a significant shift in the broader balance of 6.00/9.00 credit offerings, enrollment/budgetary factors, potential impacts on other units'

offerings, and whether these proposals could be considered new course proposals. Members noted that the Modes of Reasoning program has been successful in terms of retention, feedback, and profitability, and that these proposals were reviewed for several months within the unit. The FC Chair confirmed that the point of order raised had been noted and discussed. The CCPS Chair reiterated that CCPS members have a method of carefully reviewing each proposal and have robust conversations about the implications of any course change based on the academic merits of each proposal. A member shared the concern that the cross-listing field of each attached proposal had been selected although evidence of consultation with the cross-listed unit was not included. Responding to a member's suggestion, the AD Programs agreed that consulting with units providing General Education courses about the equitable, collegial balance across all units will be beneficial.

Item for Action:

A motion was moved, seconded, and approved to refer the proposals for AP/MODR 1730, AP/MODR 1760 and AP/MODR 1770 back to CCPS for further review. Motion carried.

The FC Chair confirmed that the remaining proposals were deemed approved as no objection to the remaining items on the Consent Agenda had been received.

7. Item for Information: Maclean's University Rankings Survey (Holly Shulman, OIPA, Senior Institutional Analyst, Research and Special Projects)

H. Shulman shared a presentation on Maclean's University Ranking Survey, highlighting York's ranking in the "Leaders of Tomorrow" and other categories, and inviting LA&PS FC members to participate in the survey and to share feedback via email.

8. Dean's Report to Council: Enrolment and Budget Update

Dean McMurtry thanked everyone who attended the Spring Open House on the previous Saturday. The Dean acknowledged that this has been a difficult time for members with a tight timeline for Chairs, Directors, and colleagues to undertake course planning revisions, and for everyone on account of the strike, international conflicts, and budgetary pressures. The Dean encouraged all to review the slideshow posted on the FC Website on their own for program-specific data, then shared the following budget and enrollment updates:

- There has been a concerning decline in the number of acceptances University-wide
- The largest decline for the University as a whole is from the Choice 1 to Choice 2 category
- There has been a significant reduction in course registration since 2020
- Salaries currently account for 101% of the LA&PS 2024/25 Budget
- LA&PS Undergraduate Course Registration: 20,000+ fewer seats are required from the high point of 2020-21 for LA&PS
- Of the \$11.5M savings requested, LA&PS is close to achieving \$7.3M in savings through reductions in courses, support staff, and operations

Motion: Extend the time of the meeting by 15 minutes (until 5:15pm). Motion was moved, seconded, and approved. Motion carried.

A member sought clarification concerning the timeline of when the Dean's Office learned of these budget cuts and when these cost-cutting exercises began. The Dean replied that there was knowledge of an approaching budget crunch in Fall 2023 but not of the magnitude we know now, adding that the Canada-India visa dispute and other issues are also contributing to the tight timeline. Members sought an update

on cost-cutting measures for senior-level administration staff and expressed concerns about the Sharp 2.0 model, the University's "strategic priorities", how FCE reductions are calculated, and how the CUPE envelope will be impacted. A request was also made for clarification of the \$8 million savings attributed to "Labour Disruption". It was mentioned that the \$8 million is contingency for the anticipated tuition loss in the Summer 2024 term due to the CUPE strike and that more information will be available in the coming weeks.

Motion: Extend the time of the meeting by 5 minutes (until 5:20pm). Motion was moved, seconded, and approved. Motion carried.

The Dean indicated that budget cuts can be achieved through various means including different modes of delivery and through whether or how to use Teaching Assistants, although this varies between units. Regarding the CUPE envelope, the Dean added that the amount of savings from cuts to staff and operating expenses has already exceeded the reductions from the costs of courses, adding that retirements can also impact teaching costs.

The Senate of York University Meeting Synopsis

The 707th Meeting of Senate Held on Thursday, 23 May 2024, via Zoom

Remarks

The Chair, Poonam Puri, welcomed Senators to the 707th meeting of Senate and noted that the disruption remediation period ends on May 26, thanking faculty, students, and staff for their efforts. She encouraged Senators to attend the June Convocation ceremonies to celebrate with students.

The President spoke to various topics, including urging faculty to attend convocation to support students and noting the honorary degree recipients, York's achievement of gold status in sustainability and its goal to reach platinum status.

Inquiries & Communications

The Academic Colleague to the Council of Ontario Universities (COU), Professor William Wijngaarden, reported that the discussion at the May meeting included the Federal Policy on Sensitive Technology Research and Affiliations of Concern and its potential strategic military implications, as well as COU's efforts with the provincial government to increase university funding.

Approvals

Senate approved a slate of candidates presented by the Executive Committee with some individuals acclaimed to positions and others to be elected by electronic ballot.

On the recommendation of its Academic Standards, Curriculum and Pedagogy Committee, Senate approved:

- the establishment of the following additional degree options for the BA program in International Studies, housed in the Department of Global and Social Studies, Glendon, effective F2025: i) a 90-credit BA degree; ii) a 90-credit BA/Bilingual degree program; iii) a 30-credit Honours BA Minor;
- the closure of the Language Endangerment, Documentation and Revitalization Stream, housed in the BA program in Linguistics and Language Studies, Glendon, effective F2025;
- changes to the Faculty Regulation on Thesis and Dissertation (Intellectual Property), Faculty of Graduate Studies, effective June 2024.

Executive

The Executive Committee's information items included the following:

- A decision on the motion submitted by Senators to establish a Senate Finance and Budget Advisory Committee, with the Vice Chair of Senate reporting that Senate Executive will be consulting the Senate APPRC Committee to gather its views on the idea of a sub-committee under its auspices with a defined advisory role on budgetary / academic resource matters, possibly populated by a combination of APPRC members and directly-elected members.
- A report on the 2024 Labour Disruption of Academic Activities: Monitoring and Reflections

Academic Policy, Planning and Research (APPRC)

Under the auspices of APPRC, the President and the Vice-President Finance and Administration delivered a presentation on the 2024-25 to 2026-27 operating budget in the context of academic planning, highlighting the university's financial management and plans, addressing challenges like tuition cuts, reduced international enrollment, and the financial impacts of Bill 124. The report outlined measures to handle the \$142.5 million deficit, focusing on enrollment recovery, revenue diversification, and cost containment to balance the budget within three years.

Academic Standards, Curriculum and Pedagogy (ASCP)

ASCP reported on Minor modifications to degree requirements at the Glendon, Osgoode, and Schulich Faculties, effective FW 2024.

Academic Policy, Planning and Research (APPRC) & Academic Standards, Curriculum and Pedagogy (ASCP)

APPRC and ASCP presented the 2022-2023 Annual Report on Non-Degree Studies.
