#### Minutes of the 129<sup>th</sup> Meeting of Council October 10<sup>th</sup>, 2024, 3:00 pm to 5:10 pm | Zoom Meeting Room

#### 1. Call to Order and Chair's Remarks

The Chair welcomed all in attendance and urged all members to join the meeting early for a timely start. Called the meeting to order.

- 2. Approval of Agenda Faculty Council (FC), October 10, 2024 Approved.
- 3. Approval of the Minutes: September 12, 2024, Faculty Council Meeting Approved
- 4. Business Arising from Minutes There was no other business.
- Item for Presentation: Discussion of LA&PS Survey results (2024-25)

The Chair shared the results of the survey and thanked all the members of LA&PS who participated and shared their opinions about collegial governance, budget, transparency, sharing of information, respectful communication and future collaborative initiatives within the faculty.

In the December 2024 Faculty Council meeting, the discussion will focus on the advantages and disadvantages of using Generative AI.

A council member shared that it would be beneficial to have one meeting per semester in person while stating that the online meetings offer greater convenience and allow for higher attendance due to the simplicity of participation. 6. Reports of Standing Committees of Faculty Council Executive Committee report: Call for nominations

The Vice Chair presented the slate of all the remaining vacancies in the faculty council and its subcommittees for the academic year 2024-2025 along with Senate vacancies.

#### Graduate Committee: Year-End Report

The Chair of the Graduate Committee presented the year-end report to the council and thanked all the committee members. Senate established a new grading scheme policy and it was well received by the departments. Secondly, all graduate programs confirmed they applied the newly developed theses and dissertations processes and formats.

#### Tenure and Promotion Committee: Year-End Report

The outgoing Tenure and Promotion Committee Chair presented the year-end report to the council. The report included a summary of the number of files and unit standards reviewed and thanked all the committee members, support staff and AD Mutimer. Additionally, encouraged all the faculty members to volunteer on this committee to fill the existing vacancies.

#### Student Academic Petitions & Appeals Committee: Year-End Report

The Chair of the Student Academic Petitions & Appeals Committee presented the year-end report to the council. The report included the petitions and appeals details and expressed gratitude to all the committee members for their hard work in reviewing and resolving the Academic Integrity cases.

A council member inquired if the committee was consulted in the development of the new policy regarding the attending physician statement. S. Wagner shared that no feedback was sought from the committee. The Chair made a note to follow up with the York Senate.

Upon inquiry from a council member S. Wagner shared that the total number of petitions this year compared to the previous year was a very slight increase but not a significant change.

### Consent Agenda: Committee on Curriculum, Curricular Policy & Standards

No objections were raised, and consent agendas were deemed approved.

#### 8. Item for Presentation: Initiatives at AD Program's office

AD Quirt thanked all the faculty members, managers and staff for volunteering at the Ontario Universities Fair on Oct 5 and 6, 2024. AD Quirt noted the importance of collaboration between the LA&PS and Central York recruitment teams to optimize resources and enhance visibility. A comprehensive overview of the recruitment, conversion, and enrollment activities conducted during 2023-2024 was presented. It was highlighted that overall enrollment has significantly declined this year, and all members were encouraged to examine the slide deck available on the FC website.

Invited all to participate in future events:

- Fall campus day on Saturday, November 2, 2024
- York Spring Open House to be held on March 15, 2025

A council member shared concerns about the 11% decline in enrollments, past strikes, challenges related to the renewal of the YUFA Collective Agreement this summer, insufficient attention given to the Auditor General's report, the reduction of courses within departments, and the depletion of the budget, which has left departments with inadequate resources for recruitment and retention initiatives. A council member shared concerns regarding the website and the search algorithms. Shared the urgency to make the website user-friendly and information accessible.

A council member emphasized the need to communicate the broader message and the need to share concrete strategic plans for action with this group.

### 9. LA&PS Dean's Report and Excellence in Teaching Dean's Award Celebration

Dean McMurtry and council congratulated all faculty members and teaching assistants. The Dean recognized their achievements as the recipients of the following awards: the Dean's Award for Excellence in Teaching and the Ian Greene Award for Teaching Excellence.

Next, Dean McMurtry shared a few updates on budget and enrolment. Departmental discussions regarding the budget have commenced, with departments detailing their expenses and revenues. All faculty members were urged to participate in meaningful discussions within their departments. These cost documents have been shared with APPC as well. Further, notable items from the presentation are as follow:

- York University 17 action plans to advance the university's academic plan and financial sustainability and encouraged all to attend the York President's consultation meeting scheduled for October 23, 2024.
- Overall, the 30-80-90 budget plan, entails substantial financial targets to be accomplished within the next three years.
- Faculties of the Future data sets to be reviewed by all and collectively discussed in future meetings.
- On November 1, 2024, all enrollment numbers will be finalized for the Fall term
- York application numbers have declined by 11%, resulting in lower acceptances and lower enrollments.

- Low enrollments impact courses significantly.
- Graduate program admission and enrollment numbers are slightly declining too.
- Winter 2025 preliminary application numbers are lower; however, there is time and these numbers could change in the coming weeks.

Points of inquiries were raised by council: A council member shared a concern regarding the budget constraints, hiring freeze and lower administrative support cause by the voluntary exit program were raised.

Second, inquiries were raised on cost-bins, their impacts to departments, and the consultation amongst higher administration.

Motion: To extend the time of the meeting by 10 minutes ending at 5:10 pm

Motion was moved, seconded and approved unanimously. Motion carried.

Dean McMurtry responded to the first inquiry that cost bins cover the central and ancillary costs. While revenues have decreased, the expenditures associated with the cost bins are rising. These expenses have been discussed previously and will remain relevant in future meetings.

Dean McMurtry also shared that the Dean's office continues to make a case for essential positions on behalf of the faculty and ensure that staffing is appropriate for the things that need to be done.

#### Minor Change to an Existing Degree or Certificate Proposals

#### **Commerce (Management) - Bachelor of Commerce Specialized Honours**

The School of Administrative Studies has proposed adding AP/ADMS 4971 - Managing for Sustainability in Costa Rica to Management Stream to the list of program electives. This is a travel abroad variant of ADMS 4970 3.00 Managing for Sustainability, already so listed. This is a simple calendar listing change with no substantive program implications.

#### **Business and Society - Business and Environment Stream**

This Department of Social Science has proposed adding AP/SOSC 4051 3.00 The Business of Fair Trade (Study Away) and AP/SOSC 4048 3.00 The Business of Fair Trade to the Environment Stream in Business and Society Program. This will create the option for students to take a seminar or community-based learning course to complete their 4000 level program requirements. The experiential learning dimension of SOSC 4051 enables students to learn first-hand how cooperatives work on a democratic basis.

#### **BA Children, Childhood & Youth**

The Department of Humanities has proposed adding seventeen existing courses to the extended list of program courses students can use to satisfy Children, Childhood & Youth (CCY) degree requirements. These approved courses are available to students but need to be added to the extended list in the academic calendar to ensure that CCY students can use them to fulfill their degree requirements.

#### English

The Department of English has proposed updating the Academic Calendar with the addition of six courses that have already been approved. There is no change to the program proposed with this update, which is expected to show students more options when selecting courses.

#### Professional Certificate in Public Policy Analysis (CPPA)

The School of Public Policy & Administration has proposed merging AP/PPAS 4310 3.00 and 4320 3.00 Program Evaluation I and II, creating one 6.00-credit course: AP/PPAS 4310 6.00 Program Evaluation. The proposed change will ensure that students take both parts in the same academic year and that they complete the same group project over two terms. The proposed change does not affect the total number of required credits in the CPPA program.

### Bachelor of Public Administration (BPA) - Specialized Honours, Honours and Honours Major/Minor

The School of Public Policy & Administration has proposed making AP/PPAS 4310 6.00 Program Evaluation (the proposed consolidated 6.00-credit version of the two existing

courses AP/PPAS 4310 3.00 and 4320 3.00 Program Evaluation I and II) mandatory for all BPA majors by moving AP/PPAS 4310 6.00 Program Evaluation to the core requirements for the Bachelor of Public Administration (BPA) Specialized Honours, Honours and Honours Major/Minor program options. The proposed change does not affect the total number of required credits in the major for BPA students.

- Opening July 2028
- Three-year MD program
- Focused on community-based learning
- 80 undergraduate learners/year -- 240 at steady state
- 102 postgraduate learners/year -- 293 at steady state
- Prioritizing primary care specialties -- family medicine, psychiatry, pediatrics, general internal medicine, obstetrics/gynecology, surgery

The Provincial government approval for a new School of Medicine was announced in the budget as "financial decision" to create an innovative new medical school that will positively impact both medical education and the design of patient care in Ontario



# **Rationale for a New School of Medicine**

## **PROBLEM TO ADDRESS**

- 1. Large shortage of primary care physicians across Ontario and Canada, many Canadians lack access to family physicians
- 2. Uncoordinated health care diminishing patient's experience
- 3. Heath care is fragmented across places of delivery, undermining prevention, wellness, and continuity
- 4. Physician population lacks diversity and experience in the communities they serve

## IMPLICATIONS FOR YORK UNIVERSITY SCHOOL OF MEDICINE

- 1. Focus on primary care physicians, with admissions, curricula, residencies, and support systems that train, place, retain, and facilitate practice and continued learning for primary care physicians
- 2. Train in inter-professional teams in personoriented approaches, facilitated by having School of Medicine in same Faculty as other health professions
- 3. Build network of clinical providers across communities, with population health approaches including social determinants of health and continuity of clinical exposures

# Medical School Financing Will it drain resources away from other Faculties?

#### **Planning costs**

• \$9 million planning grant from **Government of Ontario** 

#### Operating costs ~ **\$100** million per year at steady state

- New sources of revenue Ministry of Health to fund clinician faculty and resident salaries, and academic costs
- Ministry of Colleges and Universities provide additional grant funding for medical students (outside corridor)
- Community partners additional costs for hosting learners Funding from Ministry of Health
- Mission-critical programs (student pathways programs, interprofessional teams) Ministry of Health and philanthropy

#### Research funding – new revenue from multiple sources

- Additional research from Tri-Council and non-federal sources with expanded research program
- Indirect cost revenue shared across University (and increased Canada Research Chairs)

#### **Start-up costs – From Ministry of Health**

• Training of community physicians, development of information & communication systems

#### **Capital costs**

- Improving community sites to be ready for learning Ministry of Health
- Medical School building From philanthropy, University, and governments (City of Vaughan donated land valued at \$20 million)

# ESTABLISHMENT OF THE SCHOOL OF MEDICINE AS AN ACADEMIC UNIT AT YORK UNIVERSITY

To **establish a new academic** unit at York University, both **Senate** and the **Board of Govern**ors must approve.

Once established, a new academic unit can be home to degree programs.

This process will take place in 2 parts: • Approval in principle (Dec 2024 / Jan 2025) • Approval (Spring 2025)

#### APPROVAL OF DEGREE PROGRAMS THROUGH YUQAP PROCEDURES


Degree programs are approved through the University Senate, and then externally by the Ontario Universities Council on Quality Assurance (Quality Council for short).

Degree programs must be anchored in an existing academic unit.

For medical education, accreditation must be secured through Committee on Accreditation of Canadian Medical Schools (CACMS).
