Minutes of the 127th Meeting of Council June 13th, 2024, 3:00 pm to 5:15 pm | Zoom Meeting Room

1. Call to Order and Chair's Remarks

The interim Chair, Professor R. Kenedy, welcomed all in attendance. The Chair conveyed his gratitude for the hard work and collegiality of the previous FC Chair Professor C. Ehrlich, Dean McMurtry, Executive Committee members, FC members, staff, and Professor M. Ebrahimi for accepting the role of the Vice Chair for this meeting and going forward.

- 2. Approval of Agenda Faculty Council June 13, 2024 Approved.
- 3. Approval of the Minutes: May 9th, 2024, Faculty Council Meeting Approved
- 4. Business Arising from Minutes There was no other business.

5. Reports of Standing Committees of Faculty Council Executive Committee report

The Vice Chair presented the slate of all the vacancies in the faculty council and its subcommittees for the academic year 2024-2025 along with Senate vacancies. The Vice Chair announced that the summer nominations period is now open and will end on the floor of the September 2024 FC meeting. She extended an invitation to all members to nominate themselves or others, as this is crucial for the effective functioning of collegial governance. A council member mentioned that any additional changes to the vacancies during the summer will be communicated to the members.

Committee on Curriculum, Curricular Policy & Standards

Having received no objection to the consent agenda, it was deemed approved.

6. LA&PS Dean's Report to Council: Budget and Enrollment updates

Dean McMurtry wished all a productive summer and shared that Professor A. Davis will be leaving York. He thanked Professor Davis for her unwavering dedication and hard work as she was instrumental in the development of several initiatives such as faculty-level curricular approval processes and the establishment of the Black Studies degree.

Next, Dean McMurtry provided updates on the financial situation and what he called an enrollment crisis.

- On June 3, 2024, OUAC closed for 101 domestic students' applications and acceptances.
- Overall, York is significantly down in applications and acceptances. This decline in acceptance rates over the next 4 years will result in a negative flow-through effect on seats and courses.
- Graduate program admissions/acceptances are lower compared to previous years.
- Other faculties such as Schulich, and the Faculty of Science are offering in-house courses to accommodate their students.
- A Council member expressed concerns about the budget outlined during the York Senate meeting, which includes a 3% increase in tuition fees that was incorporated into the budget without any explanation for its necessity and rationale.
- A committee member inquired about the contingency plan for less-than-target enrollments and attrition. It was shared that the 17 action plans shared at the Senate meeting were the contingency plans in the university's central budget.

• A Council member suggested implementing alternate and innovative ways of attracting the new generation of students to LA&PS and York.

The Chair thanked Dean McMurtry for his presentation and explained that the executive committee recognized the need for Council members to engage in a thorough discussion by opening the floor for a committee of the whole. The vice chair of the FC took over the responsibilities of chairperson for the committee of the whole.

Motion: Move to the committee of the whole.

Motion was moved, seconded and approved unanimously. Motion carried.

7. Break

8. Committee of the Whole Discussions on 17 Actions to Advance York University's Academic Plan and Financial Sustainability

Vice Chair invited Councilor B. Spotton Visano to contextualize and provide an orientation of the 17 actions presented by the York President at the May 2024 Senate meeting for the advancement of York's Academic plan and financial stability.

Councilor Spotton Visano explained that these plans are part of the presentation to the Board of Governors regarding the university administration's approach to addressing and mitigating the enrollment and budget deficits. The current LA&PS Academic Plan 2021-2026 aligns with the University Academic Plan, outlining academic priorities and providing guidance on resource allocation. The division of authority between the Senate and the Board of Governors is defined by York Act (1965). Councilor Spotton Visano encouraged members to review the slide deck posted on the FC website and shared that all academic discussions related to governance structure are under the purview of APPC in LA&PS.

- A council member pointed out that "Project#13 Administrative Service Efficiencies" appears to be identical to the "Service Excellence Program," which has been in effect for a few years.
- A member expressed concerns about the new model leading to conflicts between faculties and unhealthy competition for resources and discussed not replicating the competition within LA&PS departments as introduced by the SHARP 2.0 between faculties.
- The need to investigate factors beyond labor disruptions as a cause for low enrollments and retention was stressed by a council member. It was noted that labor disruptions are issues to be addressed in labor relations. It was shared that the asks and priorities during those strikes include ensuring stability for faculty members, upholding the Collective Agreement, and securing adequate funding for graduate students which in return helps attract graduate applicants.
- A council member stated that changing general education courses will not resolve budget and enrollment issues.
- Project# 11 -Collegial Forum on UG Student Retention:
 - I. A council member shared that faculty members feel isolated while department Chairs and Directors may have more involvement. Faculty members feel distant and excluded from important discussions. Some might be invited to events but feel excluded from academic discussions.
 - II. A member stated that the program sustainability assessment was conducted a few years ago, leading to enhancements in data collection by OIPA. The data is accessible, and the availability of data necessitates a comprehensive analysis for implementing efficient recruitment and retention strategies.
 - III. A council member mentioned that York's participation in community events and visibility is significantly lacking, such as engagement with Middle Eastern and Iranian youth, and newcomers to Canada. York's absence at these events is negatively impacting

recruitment efforts by overlooking a significant pool of potential applicants and future students.

AD Quirt encouraged all FC members to share ideas and suggestions regarding enrollment, recruitment, retention, and student success strategies via email (<u>adprog@yorku.ca</u>). In response to an inquiry, AD Quirt explained that after every recruitment cycle, the university generates an applicant and non-applicant survey. Data is available about why applicants chose not to apply to York. AD Quirt acknowledged the hard work of teams responsible for supporting admissions, recruitment, and retention of students in LA&PS.

Dean McMurtry addressed several concerns related to the difficulties that post-secondary institutions are experiencing at national and global levels. Various universities are facing similar challenges, questions, and problems. The shortfall in enrollment and labor disruptions significantly impact the budget, and the resulting deficits are critical.

Rise and report: From the discussion, there is a strong will to volunteer and help the Faculty resolve its main challenges. Councilors wish to help improve student retention, recruitment, and enrollment. It was evident that faculty members actively engage with various communities to enhance York's visibility and it is imperative that the University and LA&PS make additional and concerted efforts to increase enrollment. The validity, utility, and presentation of the restructuring of general education courses were questioned by council members. Moving forward, there is a need for further discussion regarding these 17 action items, which will guide decision-making at the faculties. Members noticed a lack of accountability and self-reflection from the senior administration in the 17 action items presented. The Vice-Chair emphasized that the faculty council is the right place to have these difficult conversations, nonetheless, matters related to restructuring, and budget are a priority for our members and need to be addressed urgently.

Motion: To move out of the committee of the whole.

Motion was moved, seconded and approved by the majority of members. Motion passed.

The chair thanked all for their high level of participation and expressed hope for productive future discussions in the fall term.

Year-End Summary of the Activity of the Committee on Research Policy and Planning, 2023-2024

The following summarizes the work of the Committee on Research Policy and Planning in the 2023-24 academic year and presents the latest report.

i. Faculty of Liberal Arts & Professional Studies Minor Research Grant

The Grant Adjudication Sub-Committee awarded MRG to 37 projects during the Fall 2023 round, and 27 projects were successful in the Spring 2024. A total of \$299,651.96 was granted to successful applicants.

ii. Awards & Celebrations

The Awards & Celebrations Sub-Committee met on June 24, 2024, to adjudicate the Dean's Awards for Distinction in Research nominations. The Emerging Scholar category received one nomination; however, the committee was unable to grant an award for this year.

ITEM FOR INFORMATION: End of Year Report of the Academic Policy and Planning Committee, 2023-2024

The APPC met throughout the academic year to discuss the following items under its mandate:

- Change to Degree/Certificate requirements for programs.
- The Academic Plan for LA&PS 2021-2026: Survey was distributed to Chairs and Directors, with the deadline for responses extended to December 2023 to make progress on implementation.
- Numerous meetings were dedicated to exploring the potential of collecting data and preparing a memo on behalf of LA&PS on the Sharp budget model 2.0 along with significant budget reductions and modifications. The Dean of LA&PS consistently shared updates, while the President of York University conducts monthly Town hall sessions to address inquiries. Currently, this matter is on pause.

Over the course of the academic year, the committee:

- Collected the feedback from the Chairs and Directors regarding the Academic Plan for 2021-2026 and initiated the groundwork for the next Academic Plan. Considering the ongoing labour disruption, the committee has unanimously agreed to postpone the consultation processes for the next Academic Plan until the fall term. This decision aims to provide Chairs, Directors, and faculty members with ample time to conclude the current term and plan for the summer term.

Year-End Report of the Committee on Teaching, Learning, and Student Success, 2023-2024

The Year-End Report of the Committee on Teaching, Learning, and Student Success (CTLSS) provides a comprehensive overview of the committee's activities and initiatives during 2023-24. CTLSS met nine times throughout the academic year, with Robert McKeown serving as Chair. Key highlights include the implementation of new training for the Academic Honesty Panel, addressing challenges posed by generative AI, and assisting in the introduction of the Digital Mobile YU-Card pilot. CTLSS also provided feedback on the Joint APPRC-ASCP Taskforce's proposals for the future of pedagogy and reviewed the updated Terms of Reference for the Dean's Award for Excellence in Teaching. Significant attention was given to addressing academic integrity issues, particularly concerning ID fraud, microtechnology, and Generative AI.

Changes to Staff and Membership

Robert McKeown was Chair for CTLSS during the 2023-24 academic year. The Chair expresses gratitude to Michele Johnson, Associate Dean of Students, and Neil Buckley, Associate Dean of Teaching and Learning, for their invaluable reports and exceptional leadership. New members of the Committee included Manar Jammal from Information Technology, Damilola Adebayo from the Department of History, and Fernanda Carla-Salsberg from the Department of Languages, Literatures, and Linguistics, replacing the outgoing members: Hilary Davis, Hyunwoo Li, and Karen Ruddy. Additionally, Andrea Kalmin joined as the representative for contract faculty. CTLSS is pleased to announce a new Chair for 2024-25: Gail Vanstone, from the Department of the Humanities.

Summary of Projects and Initiatives

Academic Honesty Panel Orientation Training and Generative AI Guidance Report

AD Neil Buckley and Mary Chaktsiris created and conducted a new orientation and training session for incoming members of the Academic Honesty Panel. The training included an overview of the Academic Honesty Panels and highlighted the role of panel members when deliberating on charges of academic misconduct. Challenges related to generative artificial intelligence (AI) were presented and discussed, including the difficulty of identifying AI generated content and York University policy. Current policy prohibits the use of AI except when explicitly permitted by the course director on a class-by-class basis. No AI detectors have been authorized for use. This training better prepared new members to serve on Academic Honesty Panels and offered continuity in training for the future. Additional workshops were made available in October.

R. Sutherland-Harris and Gail Vanstone addressed the challenges posed by Generative AI in academic settings and proposed new assignment models designed to effectively assess student abilities. The proposed assignments were framed as collaborative opportunities for students to develop resume-building skills, such as leadership, organizational abilities, and technical application of course materials. These assignments were complemented by student-led assessments, which further enhanced student engagement. Additionally, collaborative reading activities, including online discussions and a shared annotated e-textbook, were recommended to encourage deeper involvement in the course material, fostering skills in annotation and citation.

New Digital Mobile YU-Card ID Pilot

The newly introduced Digital Mobile YU-Card provides an innovative solution for managing identification needs for students and staff. Accessible via Google Wallet or Apple Wallet, this digital card can be requested upon the expiration of a physical YU-Card and will serve as valid identification for various university functions, including examinations. However, CTLSS raised several concerns regarding the implementation of the Digital Mobile YU-Card. These concerns include the potential need to extend exam durations to accommodate the validation and check-in process using digital cards. Additionally, there was discussion about the necessity of updating existing examination rules to incorporate procedures for phone-based check-ins. The cost of card scanners, approximately \$500 each, also prompted concerns about funding and distribution to invigilators. The university has recommended that students carry government-issued ID for examinations, and professors have the authority to request it as the primary form of verification. During the December exam period, CTLSS members volunteered to pilot the use of digital cards. While many invigilators found the system to be a seamless way to verify identification, some expressed concerns about allowing phones on the edge of desks and potential technological issues. Despite these concerns, 50 percent of invigilators who provided feedback indicated they would be willing to reuse the scanners in future exams.

Feedback to the Joint APPRC-ASCP Taskforce on the Future of Pedagogy

CTLSS recommended offering incentives, such as teaching releases, to increase faculty engagement with the Teaching Commons, allowing educators to attend conferences and pursue professional development. However, CTLSS highlighted the need for equitable access, noting that some faculty members have heavier workloads due to higher credit assignments and extended work hours. To ensure fairness, teaching releases should be allocated more generously to those with greater responsibilities. CTLSS also stressed the ance of fostering academic community through organic methods, encouraging the creation of communities of practice to promote cross-faculty collaboration and interdisciplinary interaction. Additionally, the growing prevalence of blended courses has increased educators' workloads and required more technical expertise. CTLSS advocated for a proactive approach to AI training, emphasizing the need for professional development that helps educators refine and create assignments leveraging AI as a valuable tool. Currently, CTLSS oversees academic honesty cases at the faculty level, working with departments to track and record breaches. Initially, the Taskforce proposed shifting responsibility for assigning punishments related to breaches of academic dishonesty to course directors. However, after receiving feedback from stakeholders, including CTLSS, the Taskforce recognized the important role of CTLSS at the faculty-level to ensure fair, unbiased, and consistent punishments.

Updated Terms of Reference for the Dean's Award for Excellence in Teaching

The updated Terms of Reference bring significant improvements to the nomination and evaluation process for the DAET Awards. Key changes include the formal integration of Decolonization, Equity, Diversity, and Inclusion (DEDI) values into the award criteria, ensuring contemporary educational values are recognized. The communication of award criteria has been clarified for nominees, and the nomination process has been streamlined, particularly for teaching assistants, with a more flexible and concise application. These updates also address the need for equitable access to the process, reducing the burden on faculty and adjudicators while enhancing transparency and inclusivity. For example, course evaluations are no longer required for teaching assistants and faculty may include teaching materials if they wish. Additionally, the revised criteria emphasize a meaningful impact on student learning and contributions to the academic community, aligning more closely with York University's strategic priorities.

Identification Fraud, Microtechnology, and Generative AI

The Associate Dean reported ongoing academic honesty issues within LA&PS, particularly concerning ID fraud and the use of microtechnology, such as micro-Bluetooth headsets, to cheat during examinations. While definitive solutions to counter microtechnology violations remain challenging, the Associate Dean emphasized the importance of vigilance and preventive measures. To address ID fraud, the office has further implemented York Student electronic IDs and verification systems, aimed at preventing student impersonation during exams. The Office of Academic Honesty has been alerted to the rising use of microtechnology, including button cameras and Bluetooth headphones, prompting increased vigilance. Additionally, the transition to digital YU cards is being supported to enhance security in larger classes. The committee also discussed the potential use of browser lockdown software for online exams and alternative exam formats to counter the misuse of technology, including disruptions caused by generative AI. During the April exam period, a number of impersonations and microtechnology abuses were discovered and deliberated upon at an Academic Integrity Hearing by CTLSS members. In many cases, the recommended penalty was expulsion from the university.

Academic Honesty Panel Orientation Training

- New orientation and training session for Academic Honesty Panel members

 created by AD Neil Buckley and Mary Chaktsiris.
- ► Training updated to include issues around Generative AI.
 - Policy prohibits AI use except when explicitly permitted by the course director.
 - AI Detectors are prohibited.

Digital Mobile YU-Card Pilot

- Introduction of the Digital Mobile YU-Card accessible via Google Wallet or Apple Wallet.
- CTLSS members raised concerns about:
 - Extended exam durations for digital check-ins.
 - Funding for card scanners (approximately \$500 each).
 - Potential technological issues during exams.
- ► Mixed feedback from invigilators; 50% willing to reuse scanners.

Feedback to Joint APPRC-ASCP Taskforce

- CTLSS provided feedback to the Joint APPRC-ASCP Taskforce on the Future of Pedagogy.
- CTLSS advocated for maintaining the current practice of handling many Academic Honesty cases at the faculty level, rather than giving course directors more discretion to determine both if a breach occurred and the appropriate penalty.
- Holding hearings at the faculty level helps ensure more accurate record-keeping, a more impartial process, and greater consistency in penalties.

Updated Terms of Reference for DAET

- More clearly communicated the award criteria to nominees.
- Reduced the size of the nominee application.
- ► Increased flexibility of application components.
- Approved by Faculty Council in February 2024.

Academic Integrity: ID Fraud, Microtechnology, Generative AI

- Ongoing issues with ID fraud and microtechnology (e.g., Bluetooth headsets) were presented and discussed throughout the year.
- Multiple cases of impersonation and microtechnology misuse were detected during the April exam period.
 - Special thanks to the Office of Academic Honesty and AD Neil Buckley for collecting evidence and presenting to panel judges.
- Academic Honesty panels recommended severe penalties, including expulsion.




LA&PS Executive Committee Survey (2024-25)













The Senate of York University

Meeting Synopsis

The 708th Meeting of Senate Held on Thursday, 27 June 2024, via Zoom

Remarks

The Chair, Poonam Puri, welcomed Senators to the 708th meeting of Senate.

This being the final meeting for Senators Andrea Davis and Kim Michasiw, they were acknowledged for their distinguished records of service and thanked for their leadership and contributions to Senate-level governance.

The President provided a year-end report that reflected on progress made in 2023-2024 on each of the priorities of the *2020-2025 University Academic Plan* and the forward-looking focus on addressing the budget deficit through revenue generation and cost savings in each of the next three years.

Approvals

On the recommendation of its Academic Standards, Curriculum and Pedagogy Committee, Senate approved:

- the establishment of the Senate Academic Conduct Policy and recission of the Senate Policy on Academic Honesty, effective FW 2024-2025.
- the extension of the waiver of required attending physician statements to support requests for petitions, appeals and deferred standing for an additional six months beyond the current waiver, from 30 June 2024 to 31 December 2024.
- the recission of the Senate Policy on Pass / Fail Grades and the Senate Credit / No Credit regulation, and establishment of a new, single Senate Policy on Pass/Fail and Credit / No Credit Grades, effective F2025.

A proposed Senate Attending Physician's Statement Policy was referred back to ASCP for further review following the input of Senators.

On recommendation of the Executive Committee, Senate elected the following to serve on Senate committees / sub-committees:

- Theodore Peridis, Professor, Schulich School of Business and Othon Alexandrakis, Professor, Department of Anthropology, LAPS to the Joint Sub-committee on Quality Assurance
- Patricia Lakin-Thomas, Professor, Department of Biology, Science, Mina Singh, Professor, School of Nursing, Health and Paula Wilson, Professor, Department of Biology, Science to the Senate Tenure & Promotions Committee

On the recommendation of its Academic Policy, Planning & Research Committee, Senate approved:

- the chartering of the following Organized Research Units (ORU) for a five-year period, commencing 1 July 2024:
 - Centre for Feminist Research
 - Israel and Golda Koschitzky Centre for Jewish Studies
 - Global Labour Research Centre
 - Institute for Research on Digital Literacies
 - Mad Studies Hub.
- revisions to the Senate Policy on Research Involving Human Participants, effective 1 July 2024.

Facilitated Discussions

Under the auspices of the *Academic Policy, Planning and Research Committee,* Senate provided reflections and input on a draft planning committee structure for the School of Medicine. Senate urged that the proposed *Academic Planning Committee* for the School be formally located under the authority and oversight of Senate consistent with the powers specifically given to Senate over academic policy.

In response to a request from Senators, a discussion was held on the impact of police presence on campus in response to non-violent activity by community members on the University's academic mission, with a focus on any issues of academic policy that need further action through Senate Executive. The dialogue expressed concerns about the intimidating and unprecedented nature of the police presence, particularly its negative impact on academic integrity and the safety of visible minorities; students feeling unsafe with the militarized police presence; the suppression of self-expression and the very quick turn to use the City police. Calls were made for a comprehensive review of the decision-making process behind inviting the police on campus and for the University to rely on security staff with EDI training for managing future campus events.

- implementation of a requirement of a York University photo identification or government issued passport for entrance to write an S1 term examination.

- Minor modifications to degree requirements in LA&PS and Schulich, effective FW 2024, and conversion of admission grade requirements by Lassonde and LA&PS to align with the pending new University grading scheme.
