#### One example of a PPAS 4200 Applied Public Policy Analysis course project

**PPAS 4200 Applied Public Policy Analysis** presents an amazing opportunity to take academic theories and skills beyond the classroom, by applying them to a real-world project with community partners and stakeholders. Our policy consultancy team assessed the feasibility and viability of Universal Basic Income (UBI) in Canada, in collaboration with the Association of Municipalities of Ontario (AMO) as our client.

AMO's objective was to gain an understanding of the feasibility of a UBI program for Ontario's diverse communities. After extensive research and collaborative effort, our team delivered a report carefully detailing probable benefits, challenges, and considerations for implementation. We presented a hybrid Guaranteed Basic Income model, and coined 'The Provincial Flexibility Model,' which sought a new kind of collaboration among all levels of government. We were honoured to hear that our findings will be used by AMO to influence the parliamentary review of UBI.

Reflecting on our journey, we highly recommend this course to students. The course exemplifies the importance of collective action, and the power of policy research to promote veritable, positive change in the world. The practical application provided us with diverse opportunities to sharpen our policy skills and build valuable connections with community partners and peers. We are grateful for <a href="Professor Wilkins">Professor Wilkins</a>' support and guidance which allowed us to contribute to AMO's mission!


My journey to this point has been greatly shaped by the MPPAL program.

The Collaboration for trANslational AI tRIals (CANAIRI) seeks to establish guidance around 'translational trials' - a set of ideal practices for health settings to adopt to facilitate ethical AI translation. Expanding on the practice of 'silent trials,' the team seeks to include domains like human factors, patient engagement, environmental impact assessment, fairness, operational readiness, and more to make AI translation more efficient, comprehensive, and safe. These trials are the canary in the coal mine, telling us when AI poses a risk and when it's safe.
