

# Hearts of Freedom (HOF) Exhibit and Passage to Freedom Documentary Film Comes to York University's Osgoode Hall Law School

The Hearts of Freedom – Stories of Southeast Asian Refugees exhibit commemorates the lives of all those Southeast Asian refugees who resettled in Canada during the tumultuous war-torn period of the Vietnam War, the Cambodian Genocide, and the Laotian Civil War, which led to the Communist takeover of these countries. The Passage to Freedom documentary film is based on the HOF interviews of many of those who escaped the horrors in these countries and made their way, first, to refugee camps in Hong Kong, Thailand, Malaysia, Indonesia, and the Philippines before being resettled to Canada.

The HOF – Stories of Southeast Asian Refugees exhibit will be on display at York University's Osgoode Hall Law School Library, main entrance, from **September 13th to October 14th, 2024.** The exhibition was curated by **Professor Stephanie Phetsamay Stobbe,** Canadian Mennonite University, Winnipeg, Manitoba. Professor Stobbe is the current President of the Canadian Association for Refugees and Forced Migration Studies (CARFMS). And, most importantly, she was one of the many thousands of Southeast Asian refugees who arrived in Canada as a young child with her family.

*The late Dr. Howard Adelman,* a distinguished philosopher at York University's Department of Philosophy, was the founder and head of Operation Lifeline that brought thousands of Southeast Asians to Canada through the Canadian Private Sponsorship of Refugees Program in the 1970s and 1980s. Professor Adelman went on to establish the **Centre for Refugee Studies (CRS) at York University**, which is one of the world's leading research centers of its kind.

## **OMAA** Bursary now offers two \$5,000 awards!

The Maureen McCauley Bursary now offers two \$5,000 awards to support the education of future municipal government leaders. OMAA is delighted to announce that the Association of Municipalities of Ontario (AMO) has recently become an equal partner on this initiative. AMO is actively engaged in developing initiatives to help municipal employers with recruitment and retention under its Workforce Development Project. This commitment is another step AMO is taking to engage Ontario's municipal employers and employees, municipal staff associations, and post-secondary sector partners to attract the next generation of community builders for careers in the municipal sector.

#### The Bursary is available to any student in a post-secondary program meeting the following criteria:

- (1) Is a student residing in Ontario
- (2) Is a student that has completed at least one year of an Ontario university or an Ontario community
- college program that has the potential to lead to a municipal government career.
- (3) Has submitted the completed Application Form, accompanied by the noted requirements



The Awards Committee will assess all submissions under approved evaluation criteria. The successful candidate will be advised of their award in October. Bursary funds will be made available to the successful applicant shortly thereafter. Successful candidates will be invited to attend the Fall Workshop virtually or in person to receive their award.

Applicants must complete the application form and also develop a 2-3 minute video which would outline the significance of municipal government service delivery and the value of professional management thereof. Examples are included on our website. Applications close on 30 September 2024.

## **Student Paper Competition: Building Better Financial Futures Challenge**

The National Student Paper Competition organized by the Financial Consumer Agency of Canada (FCAC) is now open for submissions! The theme for this year's Building Better Financial Futures competition is focused on the "Five Key Consumer Building Blocks", inspired by FCAC's National Financial Literacy Strategy. We are seeking undergraduate and graduate student papers that recommend an evidence-based solution to an existing problem in Canada's financial ecosystem. Consistent with the competition's theme, proposed solutions should aim to identify ways to encourage Canadians to foster financial resilience. This could include helping Canadians navigate the financial marketplace, build just-in-time financial knowledge and confidence, or manage expenses, debt, and savings. Papers should include a relevant literature review, and a proposal for a study that could be conducted to test the effectiveness of the solution.



#### Specialist, Policy & Planning - Ontario Health

The Ontario Laboratory Medicine Program Strategic Planning & Program Development team is looking for one (1) full time, permanent Senior Specialist, Policy & Planning to support and contribute to the development and implementation of laboratory medicine programs. The Senior Specialist has expertise and experience in scanning and assessing large bodies of evidence (including academic and grey literature), and a strong grasp of verbal/written communication to contribute to and/or synthesize findings into reports, briefing notes, presentations, tools, and other products. Additionally, the Senior Specialist will require strong project management expertise and will be the main point of contact for multiple stakeholders.

#### Assistant Deputy Minister and Chief Information Officer - Ministry of Public Safety and Solicitor General

The BC Liquor Distribution Branch (LDB) is one of two branches of government that provide oversight for the beverage alcohol and non-medical cannabis industries in the province. The LDB is responsible for the wholesale distribution of liquor and cannabis and operates the retails brands BCLIQUOR (BCL) and BC Cannabis Stores (BCCS). The Assistant Deputy Minister (ADM) & Chief Information Officer provides overall vision, direction and leadership in the effective planning, implementation and sustainment of information systems and supporting infrastructure technologies within the LDB. This includes developing strategic plans and budgets and directing activities of the Information Technology division. This role provides vision and direction to LDB executive and senior management staff relating to corporate and LDB information technology issues, objectives, policies, and procedures and is responsible for the achievement of corporate strategic plan/department business plan objectives, through effective and efficient utilization of resources.

#### Specialist, Policy Data — Canada Mortgage and Housing Corporation

Join the Policy Results and Operations team at CMHC, a key partner to the Department of Housing, Infrastructure and Communities Canada in federal housing policy. The team uses data to support evidence-based policy outcomes and results and support the operations of the policy function. The specialist will support the development of solutions to complex measurement questions, working with others to design data and analytics tools to assess and forecast performance of investments in housing. They will also develop comprehensive recommendations and guidance for senior management and the government on federal housing policy and program options, program performance, and outcomes.

#### Senior Technology and Policy Advisor - Information and Privacy Commissioner of Ontario

This position will include conducting research and analysis on leading edge information technologies in support of the work of the IPC; identifying and analyzing trends in cybersecurity best practices and governance, and contribute to developing the IPC's cybersecurity policy capacity; tracking and assessing trends concerning Privacy Enhancing Technologies, and contribute to developing policy capacity and external guidance on the use or adoption of these technologies; supporting the development or assessment of artificial intelligence governance instruments; identifying and analyzing potential impacts of emerging information technologies on information management practices; developing and delivering guidance or educational materials for IPC staff, external parties and Ontarians on cybersecurity, surveillance technologies, artificial intelligence technologies, privacy enhancing technologies, and data access issues; and providing advice, support and technical analysis in access and privacy complaint investigations and appeals.

#### **Administrator of Accreditation - Safety Codes Council**

The Safety Codes Council ("the Council") is seeking an Administrator of Accreditation to lead Council's standards of accreditation. The Council accredits municipalities, agencies, corporations, and regional service commissions to administer inspections and other safety services under the Safety Codes Act. In turn, accredited organizations provide on-the-ground monitoring of compliance with safety codes, and employ safety codes officers to evaluate plans, issue permits, perform inspections, issue variances, and enforce compliance through orders.

#### Expert in International Trade and Intellectual Property Law, EDM – Cowater International

Funded by Global Affairs Canada, the Expert Deployment Mechanism for Trade and Development (EDM) provides technical assistance to Official Development Assistance (ODA)-eligible countries to maximize the development impacts of trade and investment. Over seven years (2018-2025), EDM will invest CAD 16.5 million to support Canada's developing country trading partners to negotiate, implement, benefit from, and adapt to trade and investment agreements with Canada. Design and deliver a series of training workshops for Cambodian intellectual property officials on the amendment of laws and regulations necessary to come into conformity with the provisions in international trade agreements, with particular attention to recent Canadian trade agreements. The technical expert will also be responsible for the logistics of organizing the training workshops.

#### Legal Expert in Trade Secrets Enforcement and Dispute Resolution in Canada, EDM – Cowater International

The technical expert(s) will prepare a background paper on how disputes on trade secrets are conducted under Canadian (common and civil) law. The paper will serve as a resource for negotiators and provide the foundation for a workshop to provide an in-depth examination of the law, the relevant legal procedures, and obligations in Canadian trade agreements. It is expected that the paper and workshop will include case studies of significant disputes and legal precedents; design and deliver a workshop for officials of ASEAN Member States to present and discuss the background paper. The workshop is to be delivered virtually to a maximum of 50 participants, including negotiators, intellectual property officials, legal practitioners, and judges responsible for the enforcement of trade secrets. Despite its virtual format, the workshop is expected to be highly interactive, to provide ASEAN officials an opportunity to seek detailed answers to legal and technical questions; and provide a responsive advisory service, for a period of 30 days after the delivery of the workshop, to respond to additional questions raised by the workshop participants.

#### Senior Manager, Strategic Policy - Financial Services Regulatory Authority of Ontario
