#### Solidarity Letter from the Harriet Tubman Institute in response to actions from York Popular University Palestine Encampment

The executive committee of the Harriet Tubman Institute stands in solidarity with the students of the York Popular University for Palestine encampment and condemns York University's call to militarized police to participate in the clearance of the June 5th encampment on the Commons of the York University's Keele campus. The summoning of Toronto Police and York Community Safety to forcefully dismantle the encampment, the University's bad faith statement that the students at the encampment were "a group of individuals unknown to the University," and the reasoning that the peaceful protest constituted a threat to community safety, was a clear disavow to the University's assertions of creating a meaningful dialogue with the students. In addition, the violent arrest of a graduate student, under the guise of trespass violation at a public university, is an affront to academic freedom and political expression. This is an opportunity to put in place institutional policies and procedures which can lead to more effective diplomacy and conflict resolution.

While the mandate of the Harriet Tubman Institute encompasses the study of cultures and histories of Africa and its diaspora, including histories of slavery and colonialism, it also recognizes how these legacies inform the struggles in current lives of African peoples and diasporic communities to achieve social justice. From this lens, the violent impact of police presence and surveillance on campus against students, staff and faculty constitutes a blatant equity issue specifically affecting Black and racialized peoples. Our commitment to foster an intellectual hub for research and study is directly intertwined with our dedication to social justice and collective liberation. We have witnessed how global solidarity and student activism resulted in the divestment from apartheid South Africa by academic institutions in Canada and abroad. These periods in history show us what is possible when students, staff, and faculty dare to challenge long standing policies and practices. We remain hopeful that the students of the York Popular University for Palestine movement will usher in a new era of greater accountability at York University. We also lend our voices to the solidarity action bolstered by the York Professors for Palestine group.

We, the Harriet Tubman Institute's global network of Fellows and Associates, stand in solidarity against the egregious violation and repression of students at York University

"Paid Care Worker Organizing in England" talk (Aug 20, 1:30 to 2:30 pm) Canada Research Chair in Migration Policy, Impacts and Activism Speaker Series

Dr. Duncan Fisher (University of Sheffield)

Paid care worker organising in England: practices, policy priorities, and progress?

August 20, 2024 1:30 to 2:30 pm York Lanes 208A

Although care workers lack a unified voice or influence through sectoral collective bargaining, they, and organisations representing them, undertake significant organising and activist work towards improving their situation (Johnson, Rubery, and Egan, 2021). In the English context, however, this phenomenon has received only limited attention in academic research. This paper draws on a series of

qualitative case studies of organisations engaged in care worker organising, consisting of interviews with key actors (organisers, administrators) and paid care workers, and ethnographic observations. These case studies explore the focus, strategies, and successes in approaches to care worker organising, and include both newer as well as more established trade unions, and campaign groups. This paper includes an in-depth look at one of those case studies, of an independent union, United Voices of the World, and its campaign to improve conditions for workers at a nursing home in London.

The Office of Research Services (ORS) would like to remind researchers of the upcoming deadline for the NSERC RTI Grants Program, Category 1 (Friday, October 25). Please find below important information regarding submission of your application.

IMPORTANT NOTE:

To be eligible to apply for and to hold RTI funds, applicants and co-applicants must not hold an RTI grant from the previous year's RTI competition. In other words, RTI grant applicants and co-applicants who were successful in the previous year's RTI competition are ineligible to apply for one year. #### Sloan Research Fellowships

Please find below details of the Sloan Research Fellowship sponsored by the Alfred P. Sloan Foundation. Note that the new round of competition will open on or around July 15, 2024. Please check the Foundation website after this time to confirm competition details as they may change.

### BACKGROUND

Sloan Research Fellowships are awarded annually to early-career researchers whose creativity, innovation, and research accomplishments make them stand out as the next generation of leaders. Sloan Research Fellowships seek to stimulate fundamental research by early-career scientists and scholars of outstanding promise. These two-year Fellowships are awarded yearly to 126 researchers in recognition of distinguished performance and a unique potential to make substantial contributions to their field. The 2024 Sloan Research Fellows will receive Fellowships in the amount of \$75,000 (USD) The awards are for researchers in the fields of chemistry, computer science, Earth systems science, economics, mathematics, neuroscience, physics, or a related field. The funds must be used by the Fellow for expenses supportive of their research, including staffing, professional travel, lab expenses, equipment, etc.

**ELIGIBLE APPLICANTS** 

The following eligibility requirements apply:

- · Candidates must be tenure-track, though untenured, as of September 15, 2024.
- Candidates must hold a PhD or equivalent degree in chemistry, computer science, Earth system science, economics, mathematics, neuroscience, physics, or a related field.
- Candidates must be members of a Faculty of a college, university or other degree-granting institution in the US or Canada.
- · Candidates' faculty positions must carry a regular teaching obligation.

Competitive candidates for a Fellowship generally have a strong record of significant independent research accomplishments that demonstrate creativity and the potential to become future leaders in the scientific community. They are normally several years past the completion of their Ph.D. in order to accumulate a competitive record of independent, significant research.

In keeping with the Alfred P. Sloan Foundation's longstanding support of underrepresented scholars in the sciences, the Foundation strongly encourages the nomination of qualified Black, Latinx, Native American, Alaska Native and women candidates.

#### REQUIRED MATERIALS AND EVALUATION

Candidates will likely be expected to provide the following materials in their nomination package:

- A letter from their department head or other senior researcher officially nominating the candidate and describing the candidate's qualifications, initiative, and research;
- The candidate's CV, including a list of the candidate's scientific publications;
- Two representative articles by the candidate that highlight their independent research;
- A one-page statement by the candidate describing their significant scientific work and immediate research plans;
- Three letters from other researchers written in support of the candidate's nomination (preferably writers should be arms-length and not all from the same institution); and
- A signed ORS Checklist for internal approvals.

Departments may not submit more than 3 nominees. Please notify your Faculty Research Office if you intend to apply in case internal adjudication is needed.

All nominations will be reviewed and selected by an independent selection committee of distinguished scientists in each eligible field. Fellows are selected on the basis of their independent research accomplishments, creativity, and potential to become leaders in the scientific community through their contributions to their field.

Foundation deadline: The anticipated deadline is September 15, 2024.
