Seeking Black women and Black gender-diverse people for research on sexual difficulties

SHAPE Hub poster attached.

The Sexual Health Research Laboratory at Queen's University (Kingston, ON, Canada) is seeking individuals to participate in a knowledge mobilization project that aims to identify research priority areas from the perspective of Black women and gender-diverse people experiencing sexual difficulties. We are emailing you because your organization serves Black community members, including Black women and Black gender-diverse populations. We would appreciate you sharing our study information with members of your organization, and the communities you serve.

This work is being conducted as part of the Sexual Health And genito-Pelvic pain knowledge Empowerment Hub (SHAPE) to better understand the needs and priorities of women and gender diverse people. To learn more about SHAPE, you can follow this link: https://shapehub.ca/

This particular study aims to better understand the needs and priorities of Black women and gender-diverse people. Canada's healthcare system has major inequities that directly affect women and gender diverse persons with regard to sexual dysfunction & genito-pelvic pain, but the experiences and needs of Black women and gender-diverse persons are especially underrepresented and ignored.

Participation involves completing a 20-minute online survey, with the option to participate in a follow-up 60-minute interview. Participants will be entered into prize draws for up to \$35 in e-gift cards. Interview participants will receive a \$50 gift card.

To participate, participants must be:

- A Black woman or Black gender-diverse person
 - 18 years of age or older
 - Living in Canada
 - Fluent in English





Digital Research Alliance of Canada - DRI EDIA Champions Pilot Program

Digital Research Alliance of Canada (the Alliance) recently launched the Digital Research Infrastructure (DRI) Equity, Diversity, Inclusion and Accessibility (EDIA) Champions Pilot Program call for proposals, to support a new equity, diversity, inclusion and accessibility initiative. A summary is provided below.

Objectives

To increase awareness and uptake of the Alliance's digital research infrastructure (DRI) by equity-seeking groups

The specific objectives are to fund and provide project-related training to graduate and post-graduate researchers who self-identify as belonging to equity-seeking groups, or who has a well thought out plan to promote DRI access to equity-seeking researchers, to deliver a project of their own design with the goal to connect with members of equity-seeking groups within their research community to promote and facilitate access to Alliance DRI services.

Eligible Projects

Applicants must propose a project that promotes engagement with and uptake of Alliance DRI among equity-seeking researchers and fall under the following categories:

- Training/mentoring
- Promoting/advancing DRI
- Addressing disciplinary challenges
- Driving culture change
- Informing future initiatives
- Other: will be considered

Successful applicants will receive training and onboarding to Alliance DRI with the following goals:

- to create awareness of existing DRI
- to gain knowledge of DRI access options and opportunities
- to build capacity to utilize DRI
- to develop insight on opportunities and barriers to leveraging DRI

Eligibility

To be eligible, an Applicant must:

- Meet one of the following criteria:
 - o a graduate or post-graduate researcher enrolled at a Canadian university
 - o a student enrolled at a Canadian college, CEGEP, institute or polytechnic engaged in applied research with industry or community partners
- Self-identify as one or both of the following:
 - o a member of an equity-seeking group
 - o an individual with a well-though-out strategy to reach out to an equity-seeking group
- Be affiliated with an eligible Canadian institution and must maintain such an affiliation for the duration of the award period.
- Identify a mentor from their institution or audience community, who agrees to provide support with the EDIA aspect of the project. The Applicant is required to demonstrate that EDIA expertise is in place to support the project. The mentor may also provide support with facilitation of other aspects of the project. The mentor may be a colleague or other appropriate individual; it is not required that the mentor be the Applicant's supervisor.
- Submit only one application; multiple applications will not be accepted.

Early Researcher Award Competition: Application Process & Timelines

Please note the Round 18 competition for the Early Researcher Award has launched with an agency deadline of July 25, 2024.

Again this year, researchers will be required to submit an Internal Notice of Intent and to submit the Ontario Research Fund Mitigating Economic and Geopolitical Risk Checklist.

Please note: The Internal Notice of Intent form, Application Form and detailed program guidance is attached to this email

The Early Researcher Award (ERA) program helps promising, recently-appointed Ontario researchers build their research teams of undergraduates, graduate students, post-doctoral fellows, research assistants, associates, and technicians. The goal of the program is to improve Ontario's ability to attract and retain the best and brightest research talent.

The Early Researcher Awards is open to all disciplines.

The funds are to be used over a period of five years to fund eligible expenses for a research team.

FLIGIBLE APPLICANTS

The ERA program is open on a competitive basis to researchers who:

are full-time faculty or principal investigators who, at the application deadline, are based at an eligible institution (see detailed guidelines);

have started their academic career on or after January 1, 2018; and have completed their first Doctor of Philosophy, Doctor of Veterinary Medicine degree, Medical Doctor or terminal degree on or after January 1, 2013.

These timelines may be extended in the case of eligible career interruptions:

Section 9d of the application allows the applicant to provide the review panel with details on interruptions or delays. Failure to provide information will result in the application being

deemed ineligible.

Industry positions, research associate positions and post-doctoral fellowships are not considered eligible interruptions.

Continued education, required training (e.g. medical training and fellowships), and parental leave are considered eligible interruptions, but must be clearly described in section 9d of the application. Specific dates are required. Failure to provide information will result in the application being deemed ineligible. Extension of eligibility is calculated at a 1:1 replacement (i.e., 300 days of leaves extends eligibility by only 300 days).

Note: Section 9d of the application should also be used to clearly explain, where applicable, how any previously held positions should NOT be considered as independent academic research appointments for the purposes of eligibility.

Each award is a maximum of \$100,000 and must be matched by an additional \$50,000 from the researcher's Faculty or the private sector. In addition, up to \$40,000 will be provided to the researcher's Faculty by the Ministry for indirect costs.

EVALUATION CRITERIA

ERA applications will be evaluated based on four weighted criteria:

Excellence of the Researcher (40%) Quality of the Research (30%) Development of Research Talent (20%) Strategic Value to Ontario (10%)

The applications will be ranked as exceptional, excellent, very strong, strong, moderate, or insufficient on these four weighted criteria.

It is suggested that applicants be within the last two years of the program's eligibility window to be genuinely competitive.

YOUTH RESEARCH & INNOVATION OUTREACH

Applicants are required to undertake annual youth outreach activities that primarily target high-school, middle school and elementary school students. Up to 1% (equivalent to \$1,000) of the funding provided by the government may be used for eligible expenses for developing and delivering youth outreach activities, including consumable supplies (e.g., materials for crafts, lab supplies). Funding provided by the institution and/or partner organization may not be used for youth outreach. Activities associated with youth outreach are to be undertaken during each year of the project.

Faculties will lead the development of nominations, and as such applicants are encouraged to contact their Faculty Research Offices regarding application support. The Strategic and Institutional Research Initiatives (SIRI) Unit at ORS will coordinate submission of the Full Applications, receive reference letters, and secure any required institutional signatures.

As well, to help support the nomination development process, SIRI and Research Commons will coordinate a mentorship program that engages previous York-based ERA and Premier's Research Excellence Award recipients. However, mentorship will only be provided on a demand basis at the request of the Faculty, and should target high potential applicants. If applicants are interested in utilizing this support, Faculty Research Offices should contact SIRI at siri@yorku.ca to initiate the process.

Finally, please note that all nominations should be directed through Faculties, not Organized Research Units (ORUs), given the Award's focus on graduate student support. However, ORUs are asked to ensure that their membership is made aware of the Award and to encourage interested members to pursue the opportunity, if applicable.

2025 NSFRC Prizes

Each fall (previously each spring), the Natural Sciences and Engineering Research Council (NSERC) celebrates exceptional examples of research excellence with a wide range of prizes, including:

The Gerhard Herzberg Canada Gold Medal for Science and Engineering is awarded annually to an individual whose body of work, conducted in Canada in the natural sciences or engineering, has demonstrated persistent excellence and influence. Prize: Medal and up to \$1 million for personal university-based research or to direct in some way, such as establishment of scholarships or research

NSERC John C. Polanyi Award
Created in 2006, the NSERC John C. Polanyi Award is given to an individual or team whose research, conducted in Canada, has led to a recent outstanding advance in any NSERC-supported field of the natural sciences or engineering. Prize: \$250,000 research grant.

e Canada Prize for Interdisciplinary Research in Science and Engineering

The Brockhouse Canada Prize for Interdisciplinary Research in Science and Engineering recognizes outstanding Canadian teams of researchers from different disciplines who came together to engage in research drawing on their combined knowledge and skills, and produced a record of excellent achievements in the natural sciences and engineering. Prize: \$250,000 team research grant. NSERC Donna Strickland Prize for Societal Impact of Natural Science and Engineering Research

The NSERC Donna Strickland Prize for Societal Impact of Natural Sciences and Engineering Research is awarded annually to an individual or team whose outstanding research has led to exceptional benefits for Canadian society, the environment and/or the economy. Prize: \$250,000 research grant.

Candidates may be nominated by any individual or group. See individual calls for more details

CIHR Team Grants: Healthy Youth (2024)

Building on almost a decade of federal investment in youth health and well-being, the purpose of this funding opportunity is to support research teams that bring evidence to at least two of the six youth-identified priorities of Canada's Youth Policy to inform meaningful change that improves youth health and well-being. The six priority areas are: Leadership and Impact; Health and Wellness; Innovation, Skills and Learning; Employment; Truth and Reconciliation; Environment and Climate Action.

This funding opportunity is a direct response to calls for Canada to do better when it comes to youth health and wellness, particularly with historically excluded or underrepresented youth and to put diverse youth and youth voices at the centre of multi-dimensional solutions to youth-identified priorities. While Canada offers some of the best economic, environmental, and social conditions for growing up, UNICEF reports that Canada ranked 30th out of 38 wealthy countries for children and youth physical health and survival, 28th out of 39 countries on children's environmental conditions and well-being, and 33rd out of 39 countries for children and youth being overweight. The report cards also show that health and well-being are unevenly distributed among children and youth in Canada, with a greater risk of illness falling on those most marginalized by income, race, and disability. These Healthy Youth Team Grants are part of the Healthy Youth Initiative that strives to bring research evidence to policy to make meaningful change in youth health and wellness.

Objectives:

The specific objectives of this funding opportunity are to:

- Create new knowledge through youth-led and/or youth-engaged research to improve the health and well-being of youth in Canada.
- Enhance interdisciplinary, cross-sectoral, and multi-systems approaches to youth health research and knowledge mobilization to strengthen research, shape policy, and support the relevance and uptake of research evidence.
- Increase capacity for youth-led and/or youth-engaged research, including researcher career pathways and among youth from a diversity of backgrounds to improve efficiency, amplify impact, and nurture a thriving, inclusive, and equitable health research environment.
- Strengthen research excellence and ensure maximum research impact through consideration of diverse biological and/or socio-cultural identity factors in research design, including diverse research methods such as those based in Indigenous ways of knowing.

Team Eligibility

Teams must include the following:

- Tri-partite Leadership consisting of an independent researcher, a knowledge user and a youth co-lead with lived or living experience of the topic of study.
- Intersectoral and multi-disciplinary researchers and knowledge users from two or more areas, sectors or fields of study.
- A knowledge mobilization champion.
- Include early and mid-career researchers on the team.

Value of Award

The total amount available for this funding opportunity is \$9 million, enough to fund approximately six (6) grants. This amount may increase if additional funding partners participate. The maximum amount per grant is \$300,000 per year for up to 5 years, for a total of \$1,500,000 per grant.

- \$ 4.5 million is available to fund three (3) applications relevant to the purpose and objectives of this funding opportunity
- \$ 1.5 million is available to fund one (1) application relevant to the Indigenous Youth Health research area.
- \$1.5 million is available to fund one (1) application relevant to the Two-Spirit, Trans, Non-Binary and/or other Gender Diverse Youth Health research area.
- \$ 1.5 million is available to fund one (1) application relevant to the Reducing Social Inequalities in Health among Canada's Youth research area.
- Applications relevant to each research area will be funded top down in order of ranking. Remaining applications in the competition will be pooled together and funded in rank order. If a research area is undersubscribed or lacks fundable applications, funds may be rolled into the general competition pool.

Award Period: Up to 5 years

All researchers must notify both their Faculty Research Office and the Office of Research Services (see contact details below) as early as possible about their intention to apply.

Sloan Research Fellowships

Please find below details of the Sloan Research Fellowship, sponsored by the Alfred P. Sloan Foundation. Note that the new round of competition will open on or around July 15, 2024. Please check the Foundation website after this time to confirm competition details as they may change.

Sloan Research Fellowships are awarded annually to early-career researchers whose creativity, innovation, and research accomplishments make them stand out as the next generation of leaders. Sloan Research Fellowships seek to stimulate fundamental research by early-career scientists and scholars of outstanding promise. These two-year Fellowships are awarded yearly to 126 researchers in recognition of distinguished performance and a unique potential to make substantial contributions to their field. The 2024 Sloan Research Fellows will receive Fellowships in the amount of \$75,000 (USD)

The awards are for researchers in the fields of chemistry, computer science, Earth systems science, economics, mathematics, neuroscience, physics, or a related field. The funds must be used by the Fellow for expenses supportive of their research, including staffing, professional travel, lab expenses, equipment, etc.

A list of recent Fellows is available here.

ELIGIBLE APPLICANTS

The following eligibility requirements apply:

- Candidates must be tenure-track, though untenured, as of September 15, 2024.
- · Candidates must hold a PhD or equivalent degree in chemistry, computer science, Earth system science, economics, mathematics, neuroscience, physics, or a related field.
- Candidates must be members of a Faculty of a college, university or other degree-granting institution in the US or Canada.
- · Candidates' faculty positions must carry a regular teaching obligation.

Competitive candidates for a Fellowship generally have a strong record of significant independent research accomplishments that demonstrate creativity and the potential to become future leaders in the scientific community. They are normally several years past the completion of their Ph.D. in order to accumulate a competitive record of independent, significant research.

In keeping with the Alfred P. Sloan Foundation's longstanding support of underrepresented scholars in the sciences, the Foundation strongly encourages the nomination of qualified Black, Latinx, Native American, Alaska Native and women candidates.

REQUIRED MATERIALS AND EVALUATION

 $Candidates\ will\ likely\ be\ expected\ to\ provide\ the\ following\ materials\ in\ their\ nomination\ package:$

- A letter from their department head or other senior researcher officially nominating the candidate and describing the candidate's qualifications, initiative, and research;
- The candidate's CV, including a list of the candidate's scientific publications;
- · Two representative articles by the candidate that highlight their independent research;
- A one-page statement by the candidate describing their significant scientific work and immediate research plans;
- Three letters from other researchers written in support of the candidate's nomination (preferably writers should be arms-length and not all from the same institution); and
- · A signed ORS Checklist for internal approvals.

Departments may not submit more than 3 nominees. Please notify your Faculty Research Office if you intend to apply in case internal adjudication is needed.

All nominations will be reviewed and selected by an <u>independent selection committee</u> of distinguished scientists in each eligible field. Fellows are selected on the basis of their independent research accomplishments, creativity, and potential to become leaders in the scientific community through their contributions to their field.

Foundation deadline: The anticipated deadline is September 15, 2024.

SIRI SUPPORT
