

Deliberating Senate business





"the establishment of a Faculty of Administrative Studies and the establishment of a Division of Business Administration as the first component of the Faculty of Administrative Studies." 31 May 1965

"the establishment of a Faculty of Law, on condition that the specific programmes and curricula of the Faculty be presented to the Senate for approval before teaching shall begin. 31 May 1965

"the establishment of a Faculty of Fine Arts; approved in final reading."

15 June 1966

"that Senate authorize the establishment of the degree of Master of Science, under the general regulations as those already adopted for the degree of Master of Arts."

22 October 1964

"approval of the York University Academic Plan as the first step in the ongoing planning process described in the document on Academic Planning at York University, approved by Senate in 1985."

13 May 1986

"that there be established at Atkinson College a Department of Nursing".

7 May 1991

"that Senate approve the establishment of University-wide teaching awards."

11 September 1997

"that there be established at York University a School of Women's Studies."

11 December 1997

"approve in principle the removal of all unnecessary gender reference from official documents authorized by Senate, and that Senate refer this motion to the President's Policy Committee... with a view to the implementation of gender free language in all University documents."

24 January 1985

"that Senate approve the Policy for the Ethics Review Process for Research Involving Human Participants".

24 June 1993

"that Senate approve the Senate Policy on Organized Research Units".

22 March 2012

"the establishment of one new Faculty (to be named) encompassing all of the units and programs currently housed in the Faculty of Arts and the Atkinson Faculty of Liberal and Professional Studies; and recommend that the Board of Governors establish the Faculty."

26 April 2007

"that Senate to express to SSHRC its support for universities to organize and host academic conferences free from government intervention; and confirming the principles of academic freedom must prevail with regard to all academic activities undertaken under the auspices of the university as also expressed by the President of the University, the Chair and Chair-designate of the Board of Governors."




